A BILL TO BE ENTITLED AN ACT

1 To reconstitute the Board of Education of Crisp County; to provide for legislative purpose;

2 to provide for the composition and election of said board; to provide for election districts;

3 to provide for terms of office; to provide for qualifications for office; to provide for

vacancies; to provide for meetings and quorums; to provide compensation; to provide for

continuation in office of current members; to provide for election and terms of office of

6 subsequent members; to provide for compensation of board members; to abolish the current

Board of Education of Crisp County on a date certain and shorten the terms of office of

8 certain members of such board; to provide for a referendum; to provide for effective dates;

to repeal a local constitutional amendment proposed by a certain resolution act; to repeal a

10 specific act; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

13 The purpose of this Act is to repeal the 1956 amendment to the Constitution relating to the

merger of the independent school system of the City of Cordele and the school district in the

15 County of Crisp lying outside the corporate limits of said city into one school district and to

16 reconstitute the Crisp County Board of Education.

17 SECTION 2.

18 (a) The Board of Education of Crisp County shall be composed of five members to be

- 19 elected as provided in this Act.
- 20 (b) For the purpose of electing members of the board of education, the Crisp County School
- 21 District shall be divided into five education districts. Districts 1, 2, 3, and 4 shall be and
- 22 correspond to those four numbered districts described in Appendix A attached to and made
- a part of this Act and further identified as 'User: Crisp SB Plan Name: CrispSB-2022 Plan
- 24 Type: Local'. Education District 5 shall be composed of the entire geographic area of the
- 25 Crisp County School District.
- 26 (c)(1) For the purposes of such plan:
- 27 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
- provided in the report of the Bureau of the Census for the United States decennial
- census of 2020 for the State of Georgia. The separate numeric designations in a district
- description which are underneath a VTD heading shall mean and describe individual
- 31 Blocks within a VTD as provided in the report of the Bureau of the Census for the
- 32 United States decennial census of 2020 for the State of Georgia; and
- 33 (B) Except as otherwise provided in the description of any district, whenever the
- description of any district refers to a named city, it shall mean the geographical
- boundaries of that city as shown on the census maps for the United States decennial
- census of 2020 for the State of Georgia.
- 37 (2) Any part of the Crisp County School District which is not included in any district
- described in subsection (b) of this section shall be included within that district contiguous
- to such part which contains the least population according to the United States decennial
- 40 census of 2020 for the State of Georgia.
- 41 (3) Any part of the Crisp County School District which is described in subsection (b) of
- 42 this section as being included in a particular district shall nevertheless not be included
- within such district if such part is not contiguous to such district. Such noncontiguous

part shall instead be included within that district contiguous to such part which contains

- 45 the least population according to the United States decennial census of 2020 for the State
- 46 of Georgia
- 47 (d) All members of the board who are elected thereto shall be nominated and elected in
- 48 accordance with Chapter 2 of Title 21 of the O.C.G.A., the "Georgia Election Code." Each
- 49 member shall be elected by the voters of Crisp County registered and qualified to vote for
- 50 members of the General Assembly.
- SECTION 3.
- 52 (a) Except as provided in subsection (b) of this section, the term of each board member shall
- be four years beginning on January 1 of the year following the election of the member.
- 54 (b)(1) The terms of office of the initial members elected to represent Districts 1 and 2
- and the at-large District 5 position shall be two years, beginning January 1, 2023, and
- 56 ending December 31, 2024. Thereafter, all successors to such members shall serve
- four-year terms.
- 58 (2) The initial terms of office of the members elected to represent Districts 3 and 4 shall
- be four years, beginning January 1, 2023, and ending December 31, 2026. Thereafter,
- all successors to such members shall serve four-year terms.
- 61 SECTION 4.
- Any person, to be eligible for membership on the board, must have resided in Crisp County
- for at least one year immediately preceding the date of the election and must reside in the
- 64 district from which he or she offers as a candidate for at least six months immediately
- 65 preceding the date of the election.

SECTION 5.

In the event a person who represents an education district moves his or her residence from such district, a vacancy shall exist for such district. In the event of a vacancy on the board for any reason other than the expiration of a term of office, the remaining members of the board of education shall appoint a successor to serve until the next general election in which members of the General Assembly are elected, in which election a successor shall be elected to serve out the unexpired term of office in which the vacancy occurs; provided, however, that, if a vacancy occurs within two years and 90 days of the expiration of the term of office,

the person appointed shall serve out the remainder of the term.

76 (a) At the first meeting of the board of education in January of each year, the board shall elect a chairperson, who shall be eligible to succeed himself or herself.

SECTION 6.

78 (b) A quorum of the board shall be three members.

79 **SECTION 7.**

Each member of the board of education shall be compensated in the amount of \$250.00 for each day of attendance at meetings of the board and training sessions and conferences approved by the board.

SECTION 8.

84 (a) Those members of the Board of Education of Crisp County who are serving as such on 85 the effective date of this Act and any person selected to fill a vacancy in any such office shall 86 continue to serve as such members until the member of the board elected pursuant to the 87 provisions of this Act take office on January 1, 2023.

88 (b) The two members of the Board of Education of Crisp County who are serving as such on the effective date of this Act whose terms expire on December 31, 2022, pursuant to an

90 Act providing for the merger of the existing independent school system of the City of

- 91 Cordele and the existing school districts in the County of Crisp lying outside the corporate
- 92 limits of said city, approved February 11, 1957 (Ga. L. 1957, p. 2066), as amended, shall
- 93 serve out the terms to which they were elected.
- 94 (c) Except for members provided for in subsection (b) of this section, the terms of office of
- 95 the members of the Board of Education of Crisp County who are serving as such on the
- 96 effective date of this Act shall be shortened and shall end on December 31, 2022.

97 **SECTION 9.**

- 98 Except as otherwise provided in this Act, the board of education shall be subject to all
- 99 constitutional and statutory provisions relative to county boards of education.

The election superintendent of Crisp County shall call and conduct an election as provided in this section for the purpose of submitting this Act to the electors of the Crisp County School District for approval or rejection. The election superintendent shall conduct that election on the date of the 2022 general primary and shall issue the call and conduct that election as provided by general law. The election superintendent shall cause the date and purpose of the election to be published once a week for two weeks immediately preceding the date thereof in the official organ of Crisp County. The ballot shall have written or printed

"() YES Shall the Act be approved which revises and restates the law relating to the Board of Education of Crisp County, shortens the terms of the current board
() NO of education, provides for the election of a new board of education, and repeals that constitutional amendment relating to the merger of the independent school system of the City of Cordele and the school district in the County of Crisp lying outside the corporate limits of said city, into one school district which was proposed by Resolution Act No. 20-64(e) of the 1956 General Assembly (Ga. L. 1956, p. 111) and duly ratified at the 1956 election?"

All persons desiring to vote for approval of the Act shall vote "Yes," and all persons desiring to vote for rejection of the Act shall vote "No." If more than one-half of the votes cast on such question are for approval of the Act, then Sections 1 through 9 and Section 11 of this Act shall become of full force and effect on July 1, 2022. If the Act is not so approved or if the election is not conducted as provided in this section, Sections 1 through 9 and Section 11 of this Act shall not become effective and this Act shall be automatically repealed on the first day of July immediately following that election date. The expense of such election shall be borne by Crisp County. It shall be the election superintendent's duty to certify the result thereof to the Secretary of State.

SECTION 11.

(a) The constitutional amendment relating to the merger of the independent school system of the City of Cordele and the school district in the County of Crisp lying outside the corporate limits of said city into one school district, which was proposed by Resolution Act No. 20-64(e) of the 1956 General Assembly (Ga. L. 1956, p. 111) and duly ratified at the 1956 election and continued in force and effect as part of the Constitution of the State of Georgia by an Act approved February 18, 1987 (Ga. L. 1987, p. 3552), is hereby repealed.

134 (b) An Act providing for the merger of the independent school system of the City of Cordele 135 and the school districts in the County of Crisp lying outside the corporate limits of said city, 136 so as to constitute one school district or system coextensive with the limits of said county, 137 approved February 11, 1957 (Ga. L. 1957, p. 2066), is hereby repealed in its entirety, and all 138 amendatory acts thereto are likewise repealed in their entirety.

139 **SECTION 12.**

- Except as otherwise provided in Section 10 of this Act, this Act shall become effective upon
- its approval by the Governor or upon its becoming law without such approval.

142 **SECTION 13.**

All laws and parts of laws in conflict with this Act are repealed.
