A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act creating a Board of Commissioners of Candler County, approved
- 2 March 23, 1933 (Ga. L. 1933, p. 430), as amended, particularly by an Act approved
- 3 February 15, 2012 (Ga. L. 2012, p. 3585), so as to change the description of the
- 4 commissioner districts; to provide for definitions and inclusions; to provide for continuation
- 5 in office of current members; to provide for effective dates; to repeal conflicting laws; and
- 6 for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 An Act creating a Board of Commissioners of Candler County, approved March 23, 1933
- 10 (Ga. L. 1933, p. 430), as amended, particularly by an Act approved February 15, 2012
- 11 (Ga. L. 2012, p. 3585), is amended by striking subsections (a), (b), and (b.1) of Section 1 and
- inserting in their place new subsections (a), (b), and (b.1) to read as follows:
- 13 "(a) For purposes of electing members of the board of commissioners, other than the
- chairperson, Candler County is divided into four commissioner districts. One member of
- the board shall be elected from each such district. The four commissioner districts shall

be and correspond to those four numbered districts described in Appendix A attached to

- 17 and made a part of this Act and further identified as 'User: Candler Plan
- 18 Name: Candler CC-2022 Plan Type: Local'.
- 19 (b)(1) For the purposes of such plan:
- 20 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
- 21 provided in the report of the Bureau of the Census for the United States decennial
- census of 2020 for the State of Georgia. The separate numeric designations in a district
- description which are underneath a VTD heading shall mean and describe individual
- 24 Blocks within a VTD as provided in the report of the Bureau of the Census for the
- United States decennial census of 2020 for the State of Georgia; and
- 26 (B) Except as otherwise provided in the description of any district, whenever the
- description of any district refers to a named city, it shall mean the geographical
- boundaries of that city as shown on the census maps for the United States decennial
- census of 2020 for the State of Georgia.
- 30 (2) Any part of Candler County which is not included in any district described in
- 31 subsection (a) of this section shall be included within that district contiguous to such part
- which contains the least population according to the United States decennial census
- of 2020 for the State of Georgia.
- 34 (3) Any part of Candler County which is described in subsection (a) of this section as
- being included in a particular district shall nevertheless not be included within such
- district if such part is not contiguous to such district. Such noncontiguous part shall
- instead be included within that district contiguous to such part which contains the least
- population according to the United States decennial census of 2020 for the State of
- 39 Georgia.
- 40 (b.1) The Board of Commissioners of Candler County which existed on
- December 31, 2022, is continued in existence but on and after January 1, 2023, shall be

42 constituted as provided in this Act. The Board of Commissioners of Candler County so

- 43 continued and constituted, sometimes referred to in this Act as the 'board,' shall continue to
- 44 have the powers, duties, rights, obligations, and liabilities of that board as existed
- 45 immediately prior to January 1, 2023."

46 SECTION 2.

- 47 (a) Those members of the board of commissioners of Candler County serving on the
- 48 effective date of this Act and any person selected to fill a vacancy in any such office shall
- 49 continue to serve as such members until the regular expiration of their respective terms of
- office and upon the election and qualification of their respective successors.
- 51 (b) Commissioner Districts 1, 2, 3, and 4, as they exist immediately prior to the effective
- date of this Act, shall continue to be designated as Commissioner Districts 1, 2, 3, and 4,
- respectively, but as newly described under this Act, and on and after the effective date of this
- Act, such members of the board serving from those former commissioner districts shall be
- 55 deemed to be serving from and representing their respective districts as newly described
- 56 under this Act.

57 SECTION 3.

- 58 Said Act is further amended by striking in its entirety the attachment thereto containing the
- 59 descriptions of the four commissioner districts which is identified as 'Plan: candlercc-2012
- 60 Plan Type: Local Administrator: candler cc User: bak'.
- SECTION 4.
- 62 The provisions of this Act necessary to conduct elections for the members of the board
- 63 in 2022 shall become effective upon the approval of this Act by the Governor or upon its
- 64 becoming law without such approval. The remaining provisions of this Act shall become
- 65 effective on January 1, 2023.

66 SECTION 5.

All laws and parts of laws in conflict with this Act are repealed.
