A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act entitled "An Act to provide education districts for the Calhoun County
- 2 Board of Education," approved April 13, 1992 (Ga. L. 1992, p. 6119), as amended,
- 3 particularly by an Act approved February 27, 2012 (Ga. L. 2012, p. 3619), so as to provide
- 4 new education district boundaries; to provide for definitions and inclusions; to provide for
- 5 continuation in office of the current members; to provide for related matters; to provide for
- 6 effective dates; to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 An Act entitled "An Act to provide education districts for the Calhoun County Board of
- 10 Education," approved April 13, 1992 (Ga. L. 1992, p. 6119), as amended, particularly by an
- Act approved February 27, 2012 (Ga. L. 2012, p. 3619), is amended by revising Section 1
- 12 as follows:
- "SECTION 1.
- 14 (a) For the purpose of electing members of the Board of Education of Calhoun County, the
- 15 Calhoun County School District shall be divided into five education districts. Education

Districts 1, 2, 3, 4, and 5 shall be and correspond to those five numbered districts described

- 17 in Appendix A attached to and made a part of this Act and further identified as 'User:
- 18 Calhoun Co. Plan Name: Calhoun CCSB-2022 Plan Type: Local'.
- 19 (b)(1) For the purposes of such plan:
- 20 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
- 21 provided in the report of the Bureau of the Census for the United States decennial
- census of 2020 for the State of Georgia. The separate numeric designations in a district
- description which are underneath a VTD heading shall mean and describe individual
- 24 Blocks within a VTD as provided in the report of the Bureau of the Census for the
- United States decennial census of 2020 for the State of Georgia; and
- 26 (B) Except as otherwise provided in the description of any district, whenever the
- description of any district refers to a named city, it shall mean the geographical
- boundaries of that city as shown on the census maps for the United States decennial
- census of 2020 for the State of Georgia.
- 30 (2) Any part of the Calhoun County School District which is not included in any
- education district described in subsection (a) of this section shall be included within that
- 32 education district contiguous to such part which contains the least population according
- to the United States decennial census of 2020 for the State of Georgia.
- 34 (3) Any part of the Calhoun County School District which is described in subsection (a)
- of this section as being included in a particular education district shall nevertheless not
- 36 be included within such education district if such part is not contiguous to such education
- district. Such noncontiguous part shall instead be included within that education district
- 38 contiguous to such part which contains the least population according to the United States
- decennial census of 2020 for the State of Georgia."

40 **SECTION 2.**

- 41 (a) Those members of the Board of Education of Calhoun County who are serving as such
- 42 on the effective date of this Act and any person selected to fill a vacancy in any such office
- 43 shall continue to serve as such members until the regular expiration of their respective terms
- 44 of office and upon the election and qualification of their respective successors.
- 45 (b) Education Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective date
- 46 of this Act, shall continue to be designated as Education Districts 1, 2, 3, 4, and 5,
- 47 respectively, but as newly described under this Act, and on and after the effective date of this
- 48 Act, such members of the board serving from those former education districts shall be
- 49 deemed to be serving from and representing their respective districts as newly described
- 50 under this Act.

SECTION 3.

- 52 The provisions of this Act necessary to conduct elections for the members of the Board of
- 53 Education of Calhoun County in 2022 shall become effective upon the approval of this Act
- 54 by the Governor or upon its becoming law without such approval. The remaining provisions
- of this Act shall become effective on January 1, 2023.

SECTION 4.

57 All laws and parts of laws in conflict with this Act are repealed.
