AS PASSED

A BILL TO BE ENTITLED AN ACT

1 To amend an Act creating the Board of Commissioners of Jeff Davis County, approved
2 March 25, 1958 (Ga. L. 1958, p. 3288), as amended, particularly by an Act approved April 4,
3 2012 (Ga. L. 2012, p. 4672), so as to change the description of the commissioner districts;
4 to provide for definitions and inclusions; to provide for continuation in office of current
5 members; to provide for election and terms of office of subsequent members; to provide for
6 related matters; to provide for effective dates; to repeal conflicting laws; and for other
7 purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

10 An Act creating the Board of Commissioners of Jeff Davis County, approved March 25,
11 1958 (Ga. L. 1958, p. 3288), as amended, particularly by an Act approved April 4, 2012 (Ga.
12 L. 2012, p. 4672), is amended in subsection (a) of Section 1A by revising paragraphs (3)
13 through (6) and repealing paragraph (7) as follows:

14 "(3) For the purpose of electing members of the board of commissioners, Jeff Davis
15 County shall be divided into five commissioner districts. One member of the board shall
16 be elected from each such district by majority vote of the qualified voters residing within

such commissioner district. The five commissioner districts shall be and correspond to
those five numbered districts described in Appendix A attached to and made a part of this
Act and further identified as 'User: Jeff Davis Co. Plan Name: JeffDavisCCSB-2022 Plan

20 Type: Local'.

21 (4) For the purposes of such plan:

(A) The term 'VTD' shall mean and describe the same geographical boundaries as
provided in the report of the Bureau of the Census for the United States decennial
census of 2020 for the State of Georgia. The separate numeric designations in a district
description which are underneath a VTD heading shall mean and describe individual
Blocks within a VTD as provided in the report of the Bureau of the Census for the
United States decennial census of 2020 for the State of Georgia; and

(B) Except as otherwise provided in the description of any district, whenever the
description of any district refers to a named city, it shall mean the geographical
boundaries of that city as shown on the census maps for the United States decennial
census of 2020 for the State of Georgia.

32 (5) Any part of Jeff Davis County which is not included in any district described in
33 paragraph (3) of subsection (a) of this section shall be included within that district
34 contiguous to such part which contains the least population according to the United States
35 decennial census of 2020 for the State of Georgia.

(6) Any part of Jeff Davis County which is described in subsection (a) of this section as
being included in a particular district shall nevertheless not be included within such
district if such part is not contiguous to such district. Such noncontiguous part shall
instead be included within that district contiguous to such part which contains the least
population according to the United States decennial census of 2020 for the State of
Georgia."

SECTION 2.

43 (a) Those members of the Board of Commissioners of Jeff Davis County who are serving
44 as such on the effective date of this Act and any person selected to fill a vacancy in any such
45 office shall continue to serve as such members until the regular expiration of their respective
46 terms of office and upon the election and qualification of their respective successors.

47 (b) Commissioner Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective 48 date of this Act, shall continue to be designated as Commissioner Districts 1, 2, 3, 4, and 5, 49 respectively, but as newly described under this Act, and on and after the effective date of this 50 Act, such members of the board serving from those former commissioner districts shall be 51 deemed to be serving from and representing their respective districts as newly described 52 under this Act.

SECTION 3.

54 The provisions of this Act necessary to conduct elections for the members of the Board of 55 Commissioners of Jeff Davis County in 2022 shall become effective upon the approval of 56 this Act by the Governor or upon its becoming law without such approval. The remaining 57 provisions of this Act shall become effective on January 1, 2023.

SECTION 4.

59 All laws and parts of laws in conflict with this Act are repealed.
