A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act reconstituting the Board of Education of Effingham County, approved
- 2 March 26, 1987 (Ga. L. 1987, p. 4596), as amended, so as to change the description of the
- 3 education districts; to provide for definitions and inclusions; to provide for continuation in
- 4 office of current members; to provide for related matters; to provide for effective dates; to
- 5 repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.

- 8 An Act reconstituting the Board of Education of Effingham County, approved March 26,
- 9 1987 (Ga. L. 1987, p. 4596), as amended, is amended by revising Part 2 as follows:

10 "Part 2

- 11 SECTION 2-1.
- 12 (a) The five education districts shall be and correspond to those five numbered districts
- described in Appendix A attached to and made a part of this Act and further identified as
- 14 'User: Effingham Co. Plan Name: Effingham CCSB-2022 Plan Type: Local'.
- 15 (b)(1) For the purposes of such plan:

16 (A) The term 'VTD' shall mean and describe the same geographical boundaries as 17 provided in the report of the Bureau of the Census for the United States decennial 18 census of 2020 for the State of Georgia. The separate numeric designations in a district 19 description which are underneath a VTD heading shall mean and describe individual 20 Blocks within a VTD as provided in the report of the Bureau of the Census for the 21 United States decennial census of 2020 for the State of Georgia; and 22 (B) Except as otherwise provided in the description of any district, whenever the 23 description of any district refers to a named city, it shall mean the geographical 24 boundaries of that city as shown on the census maps for the United States decennial 25 census of 2020 for the State of Georgia. 26 (2) Any part of the Effingham County School District which is not included in any 27 district described in subsection (a) of this section shall be included within that district 28 contiguous to such part which contains the least population according to the United States 29 decennial census of 2020 for the State of Georgia. 30 Any part of the Effingham County School District which is described in 31 subsection (a) of this section as being included in a particular district shall nevertheless

(3) Any part of the Effingham County School District which is described in subsection (a) of this section as being included in a particular district shall nevertheless not be included within such district if such part is not contiguous to such district. Such noncontiguous part shall instead be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2020 for the State of Georgia."

37 (a) Those members of the Board of Education of Effingham County who are serving as such 38 on the effective date of this Act and any person selected to fill a vacancy in any such office 39 shall continue to serve as such members until the regular expiration of their respective terms 40 of office and upon the election and qualification of their respective successors.

41 (b) Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective date of this Act,

- 42 shall continue to be designated as Districts 1, 2, 3, 4, and 5, respectively, but as newly
- 43 described under this Act, and on and after the effective date of this Act, such members of the
- 44 board serving from those former districts shall be deemed to be serving from and
- 45 representing their respective districts as newly described under this Act.

46 SECTION 3.

- 47 The provisions of this Act necessary to conduct elections for the members of the Board of
- 48 Education of Effingham County in 2022 shall become effective upon the approval of this Act
- 49 by the Governor or upon its becoming law without such approval. The remaining provisions
- 50 of this Act shall become effective on January 1, 2023.

SECTION 4.

52 All laws and parts of laws in conflict with this Act are repealed.
