A BILL TO BE ENTITLED

AN ACT

1 To amend an Act to re-create and establish the Board of Commissioners of Long County,
2 approved March 10, 1988 (Ga. L. 1988, p. 3755), as amended, particularly by an Act
3 approved March 13, 2012 (Ga. L. 2012, p. 4295), so as to change the description of the
4 commissioner districts; to provide for definitions and inclusions; to provide for continuation
5 in office of current members; to provide for effective dates; to provide for related matters;
6 to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act to re-create and establish the Board of Commissioners of Long County, approved
10 March 10, 1988 (Ga. L. 1988, p. 3755), as amended, particularly by an Act approved
11 March 13, 2012 (Ga. L. 2012, p. 4295), is amended by revising Section 2 as follows:

12 "SECTION 2.

13 (a) For purposes of electing members of the board of commissioners, Long County is
14 divided into five commissioner districts. One member of the board shall be elected from
15 each such district. The five commissioner districts shall be and correspond to those five

16 numbered districts described in Appendix A attached to and made a part of this Act and
17 further identified as 'User: Long Co. Plan Name: LongCCSB-2022 Plan Type: Local'.

18 (b)(1) For the purposes of such plan:

19 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
20 provided in the report of the Bureau of the Census for the United States decennial
21 census of 2020 for the State of Georgia. The separate numeric designations in a district
22 description which are underneath a VTD heading shall mean and describe individual
23 Blocks within a VTD as provided in the report of the Bureau of the Census for the
24 United States decennial census of 2020 for the State of Georgia; and

25 (B) Except as otherwise provided in the description of any district, whenever the
26 description of any district refers to a named city, it shall mean the geographical
27 boundaries of that city as shown on the census maps for the United States decennial
28 census of 2020 for the State of Georgia.

29 (2) Any part of Long County which is not included in any district described in
30 subsection (a) of this section shall be included within that district contiguous to such part
31 which contains the least population according to the United States decennial census
32 of 2020 for the State of Georgia.

33 (3) Any part of Long County which is described in subsection (a) of this section as being
34 included in a particular district shall nevertheless not be included within such district if
35 such part is not contiguous to such district. Such noncontiguous part shall instead be
36 included within that district contiguous to such part which contains the least population
37 according to the United States decennial census of 2020 for the State of Georgia."

SECTION 2.

39 (a) Those members of the Board of Commissioners of Long County who are serving as such
40 on the effective date of this Act and any person selected to fill a vacancy in any such office

41 shall continue to serve as such members until the regular expiration of their respective terms
42 of office and upon the election and qualification of their respective successors.

43 (b) Commissioner Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective
44 date of this Act, shall continue to be designated as Commissioner Districts 1, 2, 3, 4, and 5,
45 respectively, but as newly described under this Act, and on and after the effective date of this
46 Act, such members of the board serving from those former commissioner districts shall be
47 deemed to be serving from and representing their respective districts as newly described
48 under this Act.

SECTION 3.

50 The provisions of this Act necessary to conduct elections for the members of the Board of
51 Commissioners of Long County in 2022 shall become effective upon the approval of this Act
52 by the Governor or upon its becoming law without such approval. The remaining provisions
53 of this Act shall become effective on January 1, 2023.

SECTION 4.

55 All laws and parts of laws in conflict with this Act are repealed.
