A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act creating a new board of education of Lanier County, approved March 13,
- 2 1970 (Ga. L. 1970, p. 2709), as amended, particularly by an Act approved May 6, 2015
- 3 (Ga. L. 2015, p. 3706), so as to revise the education districts for the election of members of
- 4 the board of education; to provide for definitions and inclusions; to provide for terms and
- 5 continuation in office of current members; to provide for related matters; to provide for
- 6 effective dates; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 An Act creating a new board of education of Lanier County, approved March 13, 1970
- 10 (Ga. L. 1970, p. 2709), as amended, particularly by an Act approved May 6, 2015
- 11 (Ga. L. 2015, p. 3706), is amended by revising subsections (b), (c), and (k) of Section 2 as
- 12 follows:

- 13 "(b) For the purpose of electing members of the Board of Education of Lanier County,
- 14 Lanier County shall be divided into four education districts. One member of the board
- shall be elected from each such district. Those districts shall be and correspond to those
- 16 four numbered districts described in Appendix A attached to and made a part of this Act

and further identified as 'User: Lanier Co. Plan Name: LanierCCSB-2022 Plan Type:

- 18 Local'.
- 19 (c)(1) For the purposes of such plan:
- 20 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
- 21 provided in the report of the Bureau of the Census for the United States decennial
- census of 2020 for the State of Georgia. The separate numeric designations in a district
- description which are underneath a VTD heading shall mean and describe individual
- 24 Blocks within a VTD as provided in the report of the Bureau of the Census for the
- United States decennial census of 2020 for the State of Georgia; and
- 26 (B) Except as otherwise provided in the description of any district, whenever the
- description of any district refers to a named city, it shall mean the geographical
- boundaries of that city as shown on the census maps for the United States decennial
- census of 2020 for the State of Georgia.
- 30 (2) Any part of the Lanier County School District which is not included in any district
- described in subsection (b) of this section shall be included within that district contiguous
- 32 to such part which contains the least population according to the United States decennial
- census of 2020 for the State of Georgia.
- 34 (3) Any part of the Lanier County School District which is described in subsection (b)
- of this section as being included in a particular district shall nevertheless not be included
- within such district if such part is not contiguous to such district. Such noncontiguous
- part shall instead be included within that district contiguous to such part which contains
- the least population according to the United States decennial census of 2020 for the State
- 39 of Georgia."
- 40 "(k) Education Districts 1, 2, 3, and 4, as they exist immediately prior to the effective date
- 41 of this Act, shall continue to be designated as Education Districts 1, 2, 3, and 4,
- respectively, but as newly described under this Act, and, on and after the effective date of
- 43 this Act, such members of the board serving from those former education districts shall be

deemed to be serving from and representing their respective districts as newly described

45 under this Act."

46 SECTION 2.

- 47 Those members of the Board of Education of Lanier County who are serving as such on the
- 48 effective date of this Act and any person selected to fill a vacancy in any such office shall
- 49 continue to serve as such members until the regular expiration of their respective terms of
- 50 office and upon the election and qualification of their respective successors.

51 SECTION 3.

- 52 The provisions of this Act necessary to conduct elections for the members of the Board of
- 53 Education of Lanier County in 2022 shall become effective upon the approval of this Act by
- 54 the Governor or upon its becoming law without such approval. The remaining provisions
- 55 of this Act shall become effective on January 1, 2023.

SECTION 4.

57 All laws and parts of laws in conflict with this Act are repealed.
