A BILL TO BE ENTITLED AN ACT

1 To amend an Act for the election and creation of a board of commissioners for Screven

2 County, approved December 9, 1871 (Ga. L. 1871-72, p. 231), as amended, particularly by

3 an Act approved August 19, 1912 (Ga. L. 1912, p. 456), by an Act approved August 16, 1915

4 (Ga. L. 1915, p. 345), by an Act approved April 3, 1972 (Ga. L. 1972, p. 3495), and by an

5 Act approved March 5, 2012 (Ga. L. 2012, p. 3911), so as to provide for the election of

6 members of the Board of Commissioners of Screven County; to revise the districts for the

7 election of members of the board of commissioners; to provide for definitions and inclusions;

8 to provide for the filling of vacancies; to provide for qualifications; to provide for related

9 matters; to provide for effective dates; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

12 An Act for the election and creation of a board of commissioners for Screven County,

13 approved December 9, 1871 (Ga. L. 1871-72, p. 231), as amended, particularly by an Act

14 approved August 19, 1912 (Ga. L. 1912, p. 456), by an Act approved August 16, 1915

15 (Ga. L. 1915, p. 345), by an Act approved April 3, 1972 (Ga. L. 1972, p. 3495), and by an

16 Act approved March 5, 2012 (Ga. L. 2012, p. 3911), is amended by revising Section 2 as 17 follows:

18 "SECTION 2.

- 19 (a) The board of commissioners of Screven County shall be composed of seven members.
- 20 For the purpose of electing members of the board of commissioners of Screven County,
- 21 Screven County shall be divided into seven commissioner districts. One member of the
- board shall be elected from each district. The districts shall be and correspond to those
- seven numbered districts described in Appendix A attached to and made a part of this Act
- 24 and further identified as 'User: Screven Co. Plan Name: Screven CCSB-2022 Plan Type:
- 25 Local'.
- 26 (b) For the purposes of such plan:
- 27 (1) The term 'VTD' shall mean and describe the same geographical boundaries as
- provided in the report of the Bureau of the Census for the United States decennial
- census of 2020 for the State of Georgia. The separate numeric designations in a district
- description which are underneath a VTD heading shall mean and describe individual
- 31 Blocks within a VTD as provided in the report of the Bureau of the Census for the
- 32 United States decennial census of 2020 for the State of Georgia; and
- 33 (2) Except as otherwise provided in the description of any district, whenever the
- description of any district refers to a named city, it shall mean the geographical
- boundaries of that city as shown on the census maps for the United States decennial
- census of 2020 for the State of Georgia.
- 37 (c) Any part of Screven County which is not included in any district described in
- 38 subsection (a) of this section shall be included within that district contiguous to such part
- 39 which contains the least population according to the United States decennial census of 2020
- 40 for the State of Georgia.

41 (d) Any part of Screven County which is described in subsection (a) of this section as

- being included in a particular district shall nevertheless not be included within such district
- 43 if such part is not contiguous to such district. Such noncontiguous part shall instead be
- 44 included within that district contiguous to such part which contains the least population
- according to the United States decennial census of 2020 for the State of Georgia.
- 46 (e) To be eligible to be elected to membership on the board of commissioners, a person
- shall be a registered elector of Screven County eligible to vote for members of the General
- 48 Assembly and shall have resided in Screven County for a period of at least one year
- 49 immediately preceding the date of such person's election. The members of the board of
- 50 commissioners shall be elected by the qualified electors voting within their respective
- 51 commissioner districts.
- 52 (f) In the event of a vacancy on the board of commissioners for any reason other than the
- 53 expiration of the term of office, the vacancy shall be filled in accordance with the
- 54 provisions of Chapter 2 of Title 21 of the O.C.G.A., the 'Georgia Election Code,' and the
- residency requirements set forth in this Act. In the event that a member of the board of
- 56 commissioners ceases to be a resident of the commissioner district from which such
- 57 member was elected, a vacancy shall exist and shall be filled in the same manner as other
- vacancies are filled.
- 59 (g) At its first meeting each year, the members of the board of commissioners shall elect,
- by majority vote, one of their members to serve as chairperson for that year and until the
- 61 election of a chairperson in the subsequent year. A member shall be eligible to succeed
- 62 himself or herself as a member of the board and also as chairperson of the board.
- 63 (h) Those members of the board of commissioners who are serving as such on the effective
- date of this Act and any person selected to fill a vacancy in any such office shall continue
- 65 to serve as such members until the regular expiration of their respective terms of office and
- 66 upon the election and qualification of their respective successors.

67 (i) Successors to members referred to in subsections (h) this section shall be elected at the

- state-wide general election next preceding the expiration of such terms of office and shall
- 69 take office on January 1 following their election for terms of four years and until their
- 70 successors are elected and qualified.
- 71 (j) Commissioner Districts 1, 2, 3, 4, 5, 6, and 7, as they exist immediately prior to the
- 72 effective date of this Act, shall continue to be designated as Commissioner
- 73 Districts 1, 2, 3, 4, 5, 6, and 7, respectively, but as newly described under this Act, and on
- and after the effective date of this Act, such members of the board serving from those
- 75 former commissioner districts shall be deemed to be serving from and representing their
- 76 respective districts as newly described under this Act."

77 SECTION 2.

- 78 The provisions of this Act necessary to conduct elections for the members of the Board of
- 79 Commissioners of Screven County in 2022 shall become effective upon the approval of this
- 80 Act by the Governor or upon its becoming law without such approval. The remaining
- 81 provisions of this Act shall become effective on January 1, 2023.

82 SECTION 3.

83 All laws and parts of laws in conflict with this Act are repealed.
