A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act providing for the election of members of the Board of Education of
- 2 Screven County, approved April 1, 2002 (Ga. L. 2002, p. 3659), as amended, so as to revise
- 3 the districts for the election of members of the board of education; to provide for definitions
- 4 and inclusions; to provide for continuation in office of current members; to provide for
- 5 related matters; to provide for effective dates; to repeal conflicting laws; and for other
- 6 purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 An Act providing for the election of members of the Board of Education of Screven County,
- 10 approved April 1, 2002 (Ga. L. 2002, p. 3659), as amended, is amended by revising Section 1
- 11 as follows:
- "SECTION 1.
- 13 (a) The Board of Education of Screven County shall be composed of seven members. For
- 14 the purpose of electing members of the Board of Education of Screven County, the Screven
- 15 County School District shall be divided into seven education districts. One member of the

board shall be elected from each district. The districts shall be and correspond to those

- 17 seven numbered districts described in Appendix A attached to and made a part of this Act
- and further identified as 'User: Screven Co. Plan Name: Screven CCSB-2022 Plan Type:
- 19 Local'.
- 20 (b) For purposes of such plan:
- 21 (1) The term 'VTD' shall mean and describe the same geographical boundaries as
- provided in the report of the Bureau of the Census for the United States decennial census
- of 2020 for the State of Georgia. The separate numeric designations in a district
- description which are underneath a VTD heading shall mean and describe individual
- 25 Blocks within a VTD as provided in the report of the Bureau of the Census for the United
- 26 States decennial census of 2020 for the State of Georgia; and
- 27 (2) Except as otherwise provided in the description of any district, whenever the
- description of any district refers to a named city, it shall mean the geographical
- boundaries of that city as shown on the census maps for the United States decennial
- census of 2020 for the State of Georgia.
- 31 (c) Any part of the Screven County School District which is not included in any district
- described in subsection (a) of this section shall be included within that district contiguous
- 33 to such part which contains the least population according to the United States decennial
- 34 census of 2020 for the State of Georgia.
- 35 (d) Any part of the Screven County School District which is described in subsection (a)
- of this section as being included in a particular district shall nevertheless not be included
- 37 within such district if such part is not contiguous to such district. Such noncontiguous part
- 38 shall instead be included within that district contiguous to such part which contains the
- 39 least population according to the United States decennial census of 2020 for the State of
- 40 Georgia."

41 SECTION 2.

42 Said Act is further amended by repealing and reserving subsection (e) of Section 4.

43 SECTION 3.

- 44 (a) Those members of the Board of Education of Screven County who are serving as such
- 45 on the effective date of this Act and any person selected to fill a vacancy in any such office
- 46 shall continue to serve as such members until the regular expiration of their respective terms
- 47 of office and upon the election and qualification of their respective successors.
- 48 (b) Districts 1, 2, 3, 4, 5, 6, and 7, as they exist immediately prior to the effective date of this
- 49 Act, shall continue to be designated as Districts 1, 2, 3, 4, 5, 6, and 7, respectively, but as
- 50 newly described under this Act, and on and after the effective date of this Act, such members
- 51 of the board serving from those former districts shall be deemed to be serving from and
- 52 representing their respective districts as newly described under this Act.

SECTION 4.

- 54 The provisions of this Act relating to and necessary for the regular election in 2022 of
- 55 members of the Board of Education of Screven County shall become effective upon its
- 56 approval by the Governor or upon its becoming effective without such approval. This Act
- 57 shall otherwise become effective on January 1, 2023.

58 SECTION 5.

59 All laws and parts of laws in conflict with this Act are repealed.
