## A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act creating a new charter for the City of Thomson, approved March 15, 1973
- 2 (Ga. L. 1973, p. 2132), as amended, particularly by an Act approved February 27, 2012
- 3 (Ga. L. 2012, p. 3828), so as to change the description of the election districts for the
- 4 members of the city council; to provide for definitions and inclusions; to provide for the
- 5 continuation in office of the current members; to provide for related matters; to repeal
- 6 conflicting laws; and for other purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 An Act creating a new charter for the City of Thomson, approved March 15, 1973
- 10 (Ga. L. 1973, p. 2132), as amended, particularly by an Act approved February 27, 2012
- 11 (Ga. L. 2012, p. 3828), is amended by revising subsections (a) and (b) of Section 2.03 as
- 12 follows:

- 13 "(a) For the purpose of electing the members of the city council, the City of Thomson is
- 14 divided into three districts which shall be and correspond to those three numbered districts
- described in Appendix A attached to and made a part of this Act and further identified as
- 16 'User: Thomson City Council Plan Name: ThomsonCityCouncil-2022 Plan Type: Local'.

17 (b)(1) For the purposes of such plan:

(A) The term 'VTD' shall mean and describe the same geographical boundaries as provided in the report of the Bureau of the Census for the United States decennial census of 2020 for the State of Georgia. The separate numeric designations in a district description which are underneath a VTD heading shall mean and describe individual Blocks within a VTD as provided in the report of the Bureau of the Census for the United States decennial census of 2020 for the State of Georgia; and

(B) Except as otherwise provided in the description of any district, whenever the description of any district refers to a named city, it shall mean the geographical boundaries of that city as shown on the census maps for the United States decennial census of 2020 for the State of Georgia.

(2) Any part of the City of Thomson which is not included in any district described in subsection (a) of this section shall be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2020 for the State of Georgia.

(3) Any part of the City of Thomson which is described in subsection (a) of this section as being included in a particular district shall nevertheless not be included within such district if such part is not contiguous to such district. Such noncontiguous part shall instead be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2020 for the State of Georgia."

38 SECTION 2.

39 (a) Those members of the city council of the City of Thomson who are serving as such on 40 the effective date of this Act and any person selected to fill a vacancy in any such office shall 41 continue to serve as such members until the regular expiration of their respective terms of 42 office and upon the election and qualification of their respective successors.

43 (b) Districts 1, 2, and 3, as they exist immediately prior to the effective date of this Act, shall

- 44 continue to be designated as Districts 1, 2, and 3, respectively, but as newly described under
- 45 this section, and, on and after the effective date of this Act, such members of the city council
- 46 serving from those former districts shall be deemed to be serving from and representing their

47 respective districts as newly described under this Act.

48 SECTION 3.

49 All laws and parts of laws in conflict with this Act are repealed.
