A BILL TO BE ENTITLED AN ACT

1 To amend Article 7 of Chapter 4 of Title 49 of the Official Code of Georgia Annotated, 2 relating to medical assistance generally, so as to require the Department of Community 3 Health to conduct a comprehensive review of provider reimbursement rates for home and 4 community based services covered by the waiver programs; to provide for input from the 5 public, service providers, and other stakeholders; to provide for proposed rate models and 6 estimated fiscal impact; to direct the Department of Community Health to submit a waiver 7 request to the federal Centers for Medicare and Medicaid Services to authorize private 8 institutions for mental disease to qualify for Medicaid reimbursement for certain treatments; 9 to provide for implementation upon approval; to provide for related matters; to repeal 10 conflicting laws; and for other purposes.

11 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

13 Article 7 of Chapter 4 of Title 49 of the Official Code of Georgia Annotated, relating to14 medical assistance generally, is amended by adding new Code sections to read as follows:

16	(a) Beginning Fiscal Year 2024, and at least every four years thereafter, the department
17	shall conduct a comprehensive review of provider reimbursement rates for home and
18	community based services covered by the New Options Waiver (NOW) program, the
19	Comprehensive Supports Waiver Program (COMP), the Independent Care Waiver Program
20	(ICWP), the Georgia Pediatric Program (GAPP), and the Elderly and Disabled Waiver
21	Program (EDWP). Such review shall be conducted on all waiver services and shall include
22	input from the public, service providers, and other stakeholders.
23	(b) Based on the comprehensive review conducted pursuant to subsection (a) of this Code
24	section, the department shall develop proposed rate models, related documentation, and
25	associated policy changes to the policies and procedures of each waiver program. In
26	addition, the department shall provide the projected fiscal impact of implementing such
27	proposed rate models. Such proposed rate models, related documentation, associated
28	policy changes, and the projected fiscal impact shall be submitted to the board, the
29	Department of Behavioral Health and Developmental Disabilities, and the General
30	Assembly.

- 32 (a) No later than December 31, 2022, the department shall submit a waiver request to the
- 33 Centers for Medicare and Medicaid Services of the United States Department of Health and
- 34 <u>Human Services to authorize private institutions for mental disease (IMDs) to qualify for</u>
- 35 <u>Medicaid reimbursement for mental health and substance use disorder treatment.</u>
- 36 (b) Upon approval of such waiver, the department shall take all necessary steps to provide
- 37 for payment of such care at private IMDs with Medicaid funds."
