A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act to provide a new charter for the City of Social Circle, approved May 5,
- 2 2005 (Ga. L. 2005, p. 3627), as amended, so as to reapportion the city councilmembers
- 3 election districts; to provide for definitions and inclusions; to provide for continuation in
- 4 office of current members; to provide for related matters; to repeal conflicting laws; and for
- 5 other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.

- 8 An Act to provide a new charter for the City of Social Circle, approved May 5, 2005 (Ga. L.
- 9 2005, p. 3627), as amended, is amended by revising Section 5.11 as follows:
- 10 "SECTION 5.11.
- Election of mayor and councilmembers.
- 12 (a) There shall be a municipal general election biennially in the odd years on the Tuesday
- 13 next following the first Monday in November. At the general election in 2025 and every
- 14 four years thereafter, councilmembers shall be elected from Council District 1 and Council

District 3. At the municipal general election in 2023 and every four years thereafter, the

- mayor and councilmembers from Council District 2 and Council District 4 shall be elected.
- Each district councilmember shall be elected by the electors residing within the council
- district. The mayor shall be elected by the electors residing within the entire city.
- 19 (b) For the purpose of electing members of the city council, the City of Social Circle shall
- be divided into four election districts. Those election districts shall be and correspond to
- 21 those four numbered districts described in Appendix A attached to and made a part of this
- Act and further identified as 'User: Social Circle Plan Name: Social Circle CCSB-2023 Plan
- 23 Type: Local'.

- (c)(1) For the purposes of such plan:
- 25 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
- provided in the report of the Bureau of the Census for the United States decennial
- 27 census of 2020 for the State of Georgia. The separate numeric designations in an
- election district description which are underneath a VTD heading shall mean and
- describe individual Blocks within a VTD as provided in the report of the Bureau of the
- Census for the United States decennial census of 2020 for the State of Georgia; and
- 31 (B) Except as otherwise provided in the description of any election district, whenever
- 32 the description of any election district refers to a named city, it shall mean the
- 33 geographical boundaries of that city as shown on the census maps for the United States
- decennial census of 2020 for the State of Georgia.
- 35 (2) Any part of the City of Social Circle which is not included in any election district
- described in subsection (b) of this section shall be included within that election district
- contiguous to such part which contains the least population according to the United
- 38 States decennial census of 2020 for the State of Georgia.
- 39 (3) Except for any incorporated islands, any part of the City of Social Circle which is
- described in subsection (b) of this section as being included in a particular election
- district shall nevertheless not be included within such election district if such part is not

contiguous to such election district. Such noncontiguous part shall instead be included within that election district contiguous to such part which contains the least population according to the United States decennial census of 2020 for the State of Georgia."

46 (a) Those members of the City Council of the City of Social Circle who are serving as such 47 on the effective date of this Act and any person selected to fill a vacancy in any such office 48 shall continue to serve as such members until the regular expiration of their respective terms 49 of office and upon the election and qualification of their respective successors. 50 (b) Election Districts 1, 2, 3, and 4 as they existed immediately prior to the effective date of 51 this Act shall continue to be designated as Election Districts 1, 2, 3, and 4, respectively, but as newly described under this Act, and on and after the effective date of this Act, such 52 53 members of the city council serving from those former election districts shall be deemed to

be serving from and representing their respective election districts as newly described under

- 57 All laws and parts of laws in conflict with this Act are repealed.
