A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act to provide a homestead exemption from Oconee County ad valorem taxes
- 2 for county purposes in the amount of \$10,000.00 of the assessed value of the homestead for
- 3 the taxable year beginning on January 1, 1999, and \$15,000.00 of the assessed value of the
- 4 homestead for taxable years beginning on or after January 1, 2000, for certain residents of
- 5 that county who have annual incomes not exceeding \$15,000.00 and who are 65 years of age
- 6 or over, approved March 27, 1998 (Ga. L. 1998, p. 3576), so as to repeal such exemption;
- 7 to provide for compliance with constitutional requirements; to provide for a referendum,
- 8 effective dates, and automatic repeal, mandatory execution of election and judicial remedies
- 9 regarding failure to comply; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

10

- 12 An Act to provide a homestead exemption from Oconee County ad valorem taxes for county
- purposes in the amount of \$10,000.00 of the assessed value of the homestead for the taxable
- 14 year beginning on January 1, 1999, and \$15,000.00 of the assessed value of the homestead
- 15 for taxable years beginning on or after January 1, 2000, for certain residents of that county
- who have annual incomes not exceeding \$15,000.00 and who are 65 years of age or over,

17 approved March 27, 1998 (Ga. L. 1998, p. 3576), is amended by revising Section 6 as

18 follows:

19 "SECTION 6.

- The exemption granted by this Act shall apply to all taxable years ending on or before
- December 31, 2024. As of January 1, 2025, this Act shall be repealed and the exemption
- 22 provided for shall terminate."

23 SECTION 2.

- 24 In accordance with the requirements of Article VII, Section II of the Constitution of the State
- of Georgia, this Act shall not become law unless it receives the requisite two-thirds' majority
- vote in both the Senate and the House of Representatives.

SECTION 3.

- 28 The election superintendent of Oconee County shall call and conduct an election as provided
- 29 in this section for the purpose of submitting this Act to the electors of Oconee County for
- 30 approval or rejection. The election superintendent shall conduct that election on the date of
- 31 the general primary in 2024 and shall issue the call and conduct such election as provided by
- 32 general law. The election superintendent shall cause the date and purpose of the election to
- 33 be published once a week for two weeks immediately preceding the date thereof in the
- official organ of Oconee County. The ballot shall have written or printed thereon the words:

35 Shall the Act be approved that repeals an Act to provide a homestead "() YES 36 () NO exemption from Oconee County ad valorem taxes for county purposes in the 37 amount of \$15,000.00 of the assessed value of the homestead for taxable 38 years beginning on or after January 1, 2000, for certain residents of that 39 county who have annual incomes not exceeding \$15,000.00 and who are 65 40 years of age or over, provided that all of the other homestead exemption 41 questions on this ballot are approved?"

- All persons desiring to vote for approval of the Act shall vote "Yes," and all persons desiring to vote for rejection of the Act shall vote "No." If more than one-half of the votes cast on such question are for approval of the Act, and more than one-half of the votes cast on each of the questions regarding the following Acts are for approval of such Acts:
- 46 (1) An Act to provide a \$3,000.00 exemption from Oconee County school district ad 47 valorem taxes for educational purposes, with an automatic increase of such exemption 48 to \$8,000.00 on January 1, 2035;
- 49 (2) An Act to provide a \$3,000.00 exemption from Oconee County ad valorem taxes for county purposes, with an automatic increase of such exemption to \$8,000.00 on January 1, 2035;
- 52 (3) An Act to repeal the homestead exemption granted from Oconee County school 53 district ad valorem taxes for educational purposes to certain residents of that school 54 district, approved March 27, 1998 (Ga. L. 1998, p. 3568);
- 55 (4) An Act to repeal the homestead exemption granted from Oconee County ad valorem 56 taxes to certain residents of that county, approved May 4, 2006 (Ga. L. 2006, p. 4132);
- 57 (5) An Act to close to new applications the homestead exemption granted from Oconee
- County ad valorem taxes to certain residents of that county, approved May 4, 2006 (Ga.
- 59 L. 2006, p. 4127);
- 60 (6) An Act granting a homestead exemption from Oconee County ad valorem taxes for county purposes in an amount equal to the amount by which the current year assessed

value of the homestead exceeds the base year assessed value of such homestead for residents of that county who are 65 years of age or over;

- 64 (7) An Act granting a homestead exemption from Oconee County school district ad 65 valorem taxes for educational purposes in an amount equal to the amount by which the
- 66 current year assessed value of the homestead exceeds the base year assessed value of such
- 67 homestead for residents of that county who are 65 years of age or over;
- 68 (8) An Act granting a homestead exemption from Oconee County ad valorem taxes for
- 69 county purposes in the amount of \$10,000.00 for residents of that county who are 75
- years of age or older; and
- 71 (9) An Act granting a homestead exemption from Oconee County school district ad
- valorem taxes for educational purposes in the amount of \$10,000.00 for residents of that
- county who are 75 years of age or older,
- 74 Section 1 of this Act shall become of full force and effect on January 1, 2025. If the Act, or
- any one of the Acts provided for in paragraphs (1) through (9) of this section are not so
- approved or if the election on the Act or any of the Acts provided for in paragraphs (1)
- through (9) of this section is not conducted as provided in this section, Section 1 of this Act
- 78 shall not become effective, and this Act shall be automatically repealed on the first day of
- 79 January immediately following that election date. The expense of such election shall be
- 80 borne by Oconee County. It shall be the election superintendent's duty to certify the result
- 81 thereof to the Secretary of State. The provisions of this section shall be mandatory upon the
- 82 election superintendent and are not intended as directory. If the election superintendent fails
- 83 or refuses to comply with this section, any elector of Oconee County may apply for a writ
- 84 of mandamus to compel the election superintendent to perform his or her duties under this
- 85 section. If the court finds that the election superintendent has not complied with this section,
- 86 the court shall fashion appropriate relief requiring the election superintendent to call and
- 87 conduct such election on the date required by this section or on the next date authorized for
- special elections provided for in Code Section 21-2-540 of the O.C.G.A.

SECTION 4.

90 Except as otherwise provided in Section 3 of this Act, this Act shall become effective upon

- 91 its approval by the Governor or upon its becoming law without such approval, provided that:

- 101 (4) An Act to repeal the homestead exemption granted from Oconee County ad valorem
- taxes to certain residents of that county, approved May 4, 2006 (Ga. L. 2006, p. 4132);
- 103 (5) An Act to close to new applications the homestead exemption granted from Oconee
- 104 County ad valorem taxes to certain residents of that county, approved May 4, 2006 (Ga.
- 105 L. 2006, p. 4127);
- 106 (6) An Act granting a homestead exemption from Oconee County ad valorem taxes for
