## EXECUTIVE ORDER

BY THE GOVERNOR:

**WHEREAS:** The State of Georgia holds title to approximately 1.017 acres of unimproved real property located in Land Lots 88 and 89, 15th Land District, DeKalb County ("Property") as shown on the survey attached hereto as Exhibit "A"; and

**WHEREAS:** Said Property is a portion of the 6.22 acres of real property located in Land Lots 88 and 89, 15th Land District, DeKalb County acquired by virtue of a Quitclaim Deed dated June 16, 1988, being recorded in Deed Book 6204, Pages 390-392, in the office of the Clerk of Superior Court of DeKalb County, and on file with the State Properties Commission Real Property Records as RPR # 007588, which Property is under the custody of the Department of Corrections for the benefit of the Georgia Correctional Industries Administration; and

**WHEREAS:** By Official Action dated December 7, 2023, the Department of Corrections requested that custody of the Property be transferred to the Georgia Bureau of Investigations; and

**WHEREAS:** By Official Action dated October 12, 2023, the Georgia Bureau of Investigation requested custody of the Property for Georgia Bureau of Investigation's State Medical Examiners Annex Building.

**NOW, THEREFORE, PURSUANT TO THE AUTHORITY VESTED IN ME AS GOVERNOR OF THE STATE OF GEORGIA, IT IS HEREBY**

**ORDERED:** That custody of the above-defined Property located in DeKalb County, Georgia is hereby transferred from the Department of Corrections to the Georgia Bureau of Investigations.
