### EXECUTIVE ORDER

### BY THE GOVERNOR:

#### UPDATING THE GEORGIA EMERGENCY OPERATIONS PLAN

WHEREAS:

The State of Georgia may be subjected to emergencies and disasters

of various kinds and of different magnitudes; and

WHEREAS:

The State of Georgia will plan and prepare to implement effective responses to mitigate the effects of such emergencies and disasters, to protect public peace, health, and safety, and to preserve the lives

and property of the people; and

WHEREAS:

The Georgia Emergency Management Act of 1981, Code Section 38-3-1, et seq., sets forth the authority and responsibility of local governments, state agencies, and the undersigned in prevention of, preparation for, response to, and recovery from natural or manmade emergencies or hostile military or paramilitary actions; and

WHEREAS:

Code Section 38-3-2, provides that it is the responsibility of the State to ensure that preparations are adequate to deal with emergencies or disasters resulting from manmade or natural causes or enemy attack and it is necessary to provide for the common defense, to protect the public peace, health, and safety, and to preserve the lives and property of the people of this State; and

WHEREAS:

Code Section 38-3-20 tasks the Governor with appointing the Director of the Georgia Emergency Management and Homeland Security Agency, who is responsible for coordinating the activities of all organizations for emergency management and homeland security within the State, including leading the public safety response to natural disasters, homeland security activities, and other

emergencies within the State; and

WHEREAS:

Code Section 38-3-22, authorizes and empowers the Governor to exercise general direction and control over all or any part of the emergency management functions within this State, to prepare a comprehensive plan and program for emergency management, and

to delegate any authority vested under the Georgia Emergency Management Act; and

WHEREAS:

The Georgia Emergency Management and Homeland Security Agency shall establish and maintain, in collaboration with all appropriate state agencies and volunteer organizations a standardized, verifiable, performance-based, unified incident command system, to be utilized in response to emergencies and disasters; and

WHEREAS:

The Georgia Emergency Management and Homeland Security Agency will coordinate planning and lead emergency operations of all agencies, associations, authorities, boards, departments, or institutions within the State of Georgia; and

WHEREAS:

The Georgia Emergency Management and Homeland Security Agency will coordinate emergency mitigation, preparedness, prevention, response, and recovery activities in a manner consistent with the National Response Framework and the principles of the National Incident Management System; and,

WHEREAS:

The Georgia Emergency Management and Homeland Security Agency has developed and submitted to the undersigned for review and approval the 2024 Georgia Emergency Operations Plan (the "2024 GEOP"), which sets forth the policies and procedures governing the State's preparation for and coordinated response to any disasters or all-hazard events that may occur in or otherwise impact the State of Georgia.

NOW, THEREFORE, PURSUANT TO CODE SECTION 38-3-22 AND THE AUTHORITY VESTED IN ME AS GOVERNOR OF THE STATE OF GEORGIA, IT IS HEREBY

ORDERED:

That the 2024 GEOP, referenced hereto as "Exhibit 1", and on file at the Georgia Emergency Management and Homeland Security Agency, is hereby approved.

#### IT IS FURTHER

**ORDERED:** 

That Director of the Georgia Emergency Management and Homeland Security Agency, or the Director's designee, is delegated the power and authority to exercise overall direction and coordination of emergency and disaster planning and operations, as authorized by the Georgia Emergency Management Act of 1981, O.C.G.A. § 38-3-1, et seq., and stated in the 2024 GEOP.

#### IT IS FURTHER

**ORDERED:** 

That the Director of the Georgia Emergency Management and Homeland Security Agency shall be authorized to activate and deactivate the State Operations Center to support all state agencies in an emergency or disaster.

#### IT IS FURTHER

**ORDERED:** 

That all state and local government entities are directed to cooperate in the implementation of the provisions of the 2024 GEOP.

#### IT IS FURTHER

**ORDERED:** 

That the 2024 GEOP shall be binding on all state agencies providing Emergency Support Functions and shall serve as the basis to assist all local governments and citizens in times of emergencies or disasters.

**ORDERED:** 

That the coordinating, primary, and support function responsibilities for emergency management services and resources are as follows:

#### IT IS FURTHER

#### ORDERED:

That every department or agency of the State shall appoint an Emergency Coordinator and Alternate to serve during emergencies or disasters, and as a planning liaison to the Georgia Emergency Management and Homeland Security Agency.

#### IT IS FURTHER

### **ORDERED:**

That each department or agency of the State shall be responsible for its Emergency Support Functions as assigned in the 2024 GEOP.

#### IT IS FURTHER

#### **ORDERED:**

That each department or agency of the State assigned Emergency Support Function coordination responsibilities shall aid in preparation and revision of such functions, collaborate with primary and support agencies, and maintain comprehensive standard operating procedures for executing its assigned emergency services.

#### IT IS FURTHER

#### **ORDERED:**

That each department or agency of the State assigned primary and/or support responsibilities shall assign personnel to serve in the State Operations Center and/or other state command and control facilities, maintain a twenty-four (24) hour response capability, keep required reporting systems in compliance with state and federal laws and regulations, and prepare updates to the 2024 GEOP, as necessary.

#### IT IS FURTHER

#### ORDERED:

That each department or agency of the State assigned primary and/or support responsibilities shall participate in scheduled exercises and shall conduct the requisite training of personnel essential to the implementation of all assigned Emergency Support Functions.

#### IT IS FURTHER

#### ORDERED:

That each department or agency of the State assigned primary and/or support responsibilities shall participate in all after action discussions following activations of 2024 GEOP to identify and complete necessary improvement actions.

#### IT IS FURTHER

#### **ORDERED:**

That each department or agency of the State shall execute, without delay, the emergency functions so designated in the 2024 GEOP, or as further ordered or otherwise directed by the undersigned, during any emergency or disaster through the initial use of existing department or agency appropriations and all necessary department or agency personnel, regardless of normal duty assignment.

#### IT IS FURTHER

#### ORDERED:

That all other agencies, associations, authorities, boards, departments, or institutions of the State not assigned a primary or support role in the 2024 GEOP will carry out whatever duties or services that may be required during an emergency or disaster as specified or directed by the Governor or the Director of the Georgia Emergency Management and Homeland Security Agency.

#### IT IS FURTHER

#### ORDERED:

That when the Governor declares a State of Emergency, the Department of Public Safety, with assistance from other law enforcement agencies, including the Georgia Department of Defense, shall at the direction of the Governor, be authorized to enforce criminal laws and assist with evacuations in the State, if required.

#### IT IS FURTHER

### **ORDERED:**

That if one or more of the provisions contained in this Order shall be held to be invalid, in violation of the Georgia Constitution, in violation of Georgia law, or unenforceable in any respect, such invalidity, violation, or unenforceability shall not affect any other provisions of this Order, but, in such case, this Order shall be construed as if such invalid, illegal, or unenforceable provision had never been contained within the Order.

#### IT IS FURTHER

**ORDERED:** 

That no provision of this Order shall limit, infringe, suspend, or supplant any judicial order, judgment, or decree issued pursuant to the laws or Constitution of this State or the laws or Constitution of the United States, nor shall any person use any provision of this Order as a defense to an action in violation of a judicial order, judgment, or decree by any court created pursuant to the laws or Constitution of this State or the laws or Constitution of the United States.

#### IT IS FURTHER

**ORDERED:** 

That this Order does not suspend operation of any state or federal law or regulation, except as specifically described herein.

#### IT IS FURTHER

**Ordered:** 

The Director of the Georgia Emergency Management and Homeland Security Agency shall make necessary changes to the 2024 GEOP with appropriate coordination and shall similarly promulgate additional annexes and appendices as required.

#### IT IS FURTHER

**ORDERED:** 

All provisions of the Order shall become effective upon signature and shall remain in effect until rescinded or superseded.
