# A BILL TO BE ENTITLED AN ACT

To amend an Act creating a board of commissioners for Banks County, approved August 19, (Ga. L. 1916, p. 349), as amended, particularly by an Act approved February 17, 2022 (Ga. L. 2022, p. 4500), so as to change the description of the commissioner districts; to provide for definitions and inclusions; to provide for the continuation in office of current members; to provide for effective dates; to provide for related matters; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

#### **SECTION 1.**

9 Act creating a board of commissioners for Banks County, approved August 19, 1916
10 (Ga. L. 1916, p. 349), as amended, particularly by an Act approved February 17, 2022
11 (Ga. L. 2022, p. 4500), is amended by revising Section 2 as follows:

### "SECTION 2.

(a) For the purpose of electing members of the board of commissioners, Banks Countyshall be divided into five commissioner districts. Commissioner Districts 1, 2, 3, and 4

15 shall be and correspond to those four numbered districts described in Appendix A, attached 16 to and made a part of this Act and further identified as 'User: Banks CC Plan Name: 17 BanksCC-2025 Plan Type: Local'. Commissioner District 5 shall be comprised of the 18 entire geographic area of Banks County and the person elected from such district shall 19 serve as the chairperson of the board of commissioners.

20 (b)(1) For the purposes of such plan:

(A) The term 'VTD' shall mean and describe the same geographical boundaries as
provided in the report of the Bureau of the Census for the United States decennial
census of 2020 for the State of Georgia. The separate numeric designations in a district
description which are underneath a VTD heading shall mean and describe individual
Blocks within a VTD as provided in the report of the Bureau of the Census for the
United States decennial census of 2020 for the State of Georgia; and

(B) Except as otherwise provided in the description of any district, whenever the
description of any district refers to a named city, it shall mean the geographical
boundaries of that city as shown on the census maps for the United States decennial
census of 2020 for the State of Georgia.

31 (2) Any part of Banks County which is not included in any district described in
32 subsection (a) of this section shall be included within that district contiguous to such part
33 which contains the least population according to the United States decennial census
34 of 2020 for the State of Georgia.

(3) Any part of Banks County which is described in subsection (a) of this section as
being included in a particular district shall nevertheless not be included within such
district if such part is not contiguous to such district. Such noncontiguous part shall
instead be included within that district contiguous to such part which contains the least
population according to the United States decennial census of 2020 for the State of
Georgia."

41	SECTION 2.
42	(a) Those members of the Board of Commissioners of Banks County who are serving as
43	such on the effective date of this Act and any person selected to fill a vacancy in any such
44	office shall continue to serve as such members until the regular expiration of their respective
45	terms of office and upon the election and qualification of their respective successors.
46	(b) Commissioner Districts 1, 2, 3, and 4, as they exist immediately prior to the effective
47	date of this Act, shall continue to be designated as Commissioner Districts 1, 2, 3, and 4,
48	respectively, but as newly described under this Act, and on and after the effective date of this
49	Act, such members of the board serving from those former commissioner districts shall be
50	deemed to be serving from and representing their respective districts as newly described
51	under this Act.
