A BILL TO BE ENTITLED AN ACT

To authorize the City of Lyons, Georgia, to exercise all redevelopment and other powers 1 provided for under Article IX, Section II, Paragraph VII(b) of the Georgia Constitution and 2 3 Chapter 44 of Title 36 of the O.C.G.A., the "Redevelopment Powers Law," as amended; to 4 provide for a referendum; to provide for effective dates; to provide for automatic repeal 5 under certain circumstances; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

8 The City of Lyons, Georgia, shall be and is authorized to exercise all redevelopment and 9 other powers provided for under Chapter 44 of Title 36 of the O.C.G.A., the "Redevelopment 10 Powers Law," as amended. The intention of this Act is to authorize the City of Lyons to 11 undertake and carry out community redevelopment, to create tax allocation districts, to issue 12 tax allocation bonds, and to incur other obligations within the meaning of and as fully 13 permitted under the provisions of Article IX, Section II, Paragraph VII(b) of the Constitution 14 of the State of Georgia of 1983, as amended, and to authorize the City of Lyons to exercise 15 redevelopment powers as fully as the "Redevelopment Powers Law" may now or hereafter

permit and not to limit any redevelopment powers permitted under the "RedevelopmentPowers Law."

SECTION 2.

19 The election superintendent of the City of Lyons shall call and conduct an election, as 20 provided in this section, for the purpose of submitting this Act to the electors of the City of 21 Lyons for approval or rejection. The election superintendent shall conduct that election on 22 the Tuesday after the first Monday in November, 2025, and shall issue the call and conduct 23 that election as provided by general law. The election superintendent shall cause the date and 24 purpose of the election to be published once at least 90 days immediately preceding the date 25 thereof and once a week for two weeks immediately preceding the date thereof in the official organ of Toombs County, Georgia. The ballot shall have written or printed thereon the 26 27 words:

"() YES Shall the Act be approved which authorizes the City of Lyons, Georgia, to
exercise all redevelopment powers allowed under the 'Redevelopment
() NO Powers Law,' as it may be amended from time to time?"

31 All persons desiring to vote for approval of the Act shall vote "Yes," and all persons desiring 32 to vote for rejection of the Act shall vote "No." If more than one-half of the votes cast on 33 such question are for approval of the Act, then Section 1 of this Act shall become of full 34 force and effect immediately. If this Act is not so approved or if the election is not conducted as provided in this section, Section 1 of this Act shall not become effective and 35 36 this Act shall be automatically repealed on the first day of January immediately following 37 such election date. The expense of such election shall be borne by the City of Lyons. It shall 38 be the election superintendent's duty to certify the result thereof to the Secretary of State.
