House Bill 820 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED AN ACT

- 1 To provide a homestead exemption from Jasper County school district ad valorem taxes for
- 2 educational purposes in the amount of \$40,000.00 of the assessed value of the homestead for
- 3 residents of that school district who are 65 years of age or older; to provide for definitions;
- 4 to specify the terms and conditions of the exemption and the procedures relating thereto; to
- 5 provide for applicability; to provide for compliance with constitutional requirements; to
- 6 provide for a referendum, effective dates, automatic repeal, mandatory execution of election,
- 7 and judicial remedies regarding failure to comply; to provide for related matters; to repeal
- 8 conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

11 (a) As used in this Act, the term:

- 12 (1) "Ad valorem taxes for educational purposes" means all ad valorem taxes for
- educational purposes levied by, for, or on behalf of the Jasper County school district,
- including, but not limited to, any ad valorem taxes to pay interest on and to retire county
- school district bonded indebtedness.

16 (2) "Homestead" means homestead as defined and qualified in Code Section 48-5-40 of

- the O.C.G.A., as amended, with the additional qualification that it shall include not more
- than five contiguous acres of homestead property.
- 19 (3) "Senior citizen" means a person who is 65 years of age or older on or before January
- 20 1 of the year in which application for the exemption under subsection (b) of this section
- 21 is made.
- 22 (b) Each resident of the Jasper County school district who is a senior citizen is granted an
- 23 exemption on such person's homestead from Jasper County school district ad valorem taxes
- 24 for educational purposes in the amount of \$40,000.00 of the assessed value of such
- 25 homestead. The value of that property in excess of such exempted amount shall remain
- 26 subject to taxation.
- 27 (c) A person shall not receive the homestead exemption granted by subsection (b) of this
- 28 section unless such person or person's agent files an application with the tax commissioner
- 29 of Jasper County, giving such person's age and such additional information relative to
- 30 receiving such exemption as will enable the tax commissioner of Jasper County to make a
- 31 determination regarding the initial and continuing eligibility of such person for such
- 32 exemption; provided, however, that any qualifying person who has already applied for and
- 33 been granted an exemption from Jasper County school district ad valorem taxes for
- 34 educational purposes granted by an Act to provide a homestead exemption from certain
- 35 Jasper County ad valorem taxes for county purposes in the amount of \$2,000.00 of the
- 36 assessed value of that homestead for certain residents of that county, approved April 17, 1992
- 37 (Ga. L. 1992, p. 6508), as amended by an Act approved March 27, 1998 (Ga. L. 1998,
- 38 p. 3829), shall automatically qualify for and be granted the exemption provided for by
- 39 subsection (b) of this section without needing to reapply. The tax commissioner of Jasper
- 40 County shall provide application forms for this purpose.
- 41 (d) The exemption shall be claimed and returned as provided in Code Section 48-5-50.1 of
- 42 the O.C.G.A., as amended. The exemption shall be automatically renewed from year to year

so long as the person granted the homestead exemption under subsection (b) of this section occupies the residence as a homestead. After such person has filed the proper application as provided in subsection (c) of this section, it shall not be necessary to make application thereafter for any year, and such exemption shall continue to be allowed to such person. It shall be the duty of any such person granted the homestead exemption under subsection (b) of this section to notify the tax commissioner of Jasper County in the event that such person for any reason becomes ineligible for such exemption. The surviving spouse of the person who has been granted the exemption provided for in subsection (b) of this section shall continue to receive the exemption provided under subsection (b) of this section, so long as that surviving spouse continues to occupy the home as a residence and homestead. (e) The exemption granted by subsection (b) of this section shall not apply to or affect any state ad valorem taxes, county ad valorem taxes for county purposes, municipal ad valorem taxes for municipal purposes, or independent school district ad valorem taxes for educational purposes. The homestead exemption granted by subsection (b) of this section shall be in addition to and not in lieu of any other homestead exemption applicable to Jasper County school district ad valorem taxes for educational purposes; provided, however, that this exemption granted by subsection (b) of this section shall be in lieu of and not in addition to any exemption granted by an Act to provide a homestead exemption from certain Jasper County ad valorem taxes for county purposes in the amount of \$2,000.00 of the assessed value of that homestead for certain residents of that county, approved April 17, 1992 (Ga. L. 1992, p. 6508), as amended by an Act approved March 27, 1998 (Ga. L. 1998, p. 3829). (f) The exemption granted by subsection (b) of this section shall apply to all taxable years beginning on or after January 1, 2026.

66 SECTION 2.

In accordance with the requirements of Article VII, Section II of the Constitution of the State of Georgia, this Act shall not become law unless it receives the requisite two-thirds' majority vote in both the Senate and the House of Representatives.

70 SECTION 3.

The election superintendent of Jasper County shall call and conduct an election as provided in this section for the purpose of submitting this Act to the electors of the Jasper County school district for approval or rejection. The election superintendent shall conduct that election on the Tuesday following the first Monday in November, 2025, and shall issue the call and conduct that election as provided by general law. The election superintendent shall cause the date and purpose of the election to be published once a week for two weeks immediately preceding the date thereof in the official organ of Jasper County. The ballot shall have written or printed thereon the words:

"() YES Shall the Act be approved which provides a homestead exemption from Jasper County school district ad valorem taxes for educational purposes in () NO the amount of \$40,000.00 of the assessed value of the homestead for residents of that school district who are 65 years of age or older?"

All persons desiring to vote for approval of the Act shall vote "Yes," and all persons desiring to vote for rejection of the Act shall vote "No." If more than one-half of the votes cast on such question are for approval of the Act, Section 1 of this Act shall become of full force and effect on January 1, 2026. If the Act is not so approved or if the election is not conducted as provided in this section, Section 1 of this Act shall not become effective, and this Act shall be automatically repealed on the 365th calendar day following the election date provided for in this section. The expense of such election shall be borne by Jasper County. It shall be the election superintendent's duty to certify the result thereof to the Secretary of State. The provisions of this section shall be mandatory upon the election superintendent and are not

intended as directory. If the election superintendent fails or refuses to comply with this section, any elector of the Jasper County school district may apply for a writ of mandamus to compel the election superintendent to perform his or her duties under this section. If the court finds that the election superintendent has not complied with this section, the court shall fashion appropriate relief requiring the election superintendent to call and conduct such election on the date required by this section or on the next date authorized for special elections provided for in Code Section 21-2-540 of the O.C.G.A.
