A BILL TO BE ENTITLED AN ACT

1 To amend an Act to provide for a homestead exemption from City of Dalton independent school district ad valorem taxes for educational purposes in the amount of \$150,000.00 of 2 3 the assessed value of the homestead for residents of that school district who are 70 years of 4 age or over, approved May 17, 2004 (Ga. L. 2004, p. 3763), as amended, so as to increase such exemption; to provide for compliance with constitutional requirements; to provide for 5 6 a referendum, effective dates, and automatic repeal; to provide for mandatory execution of 7 election and judicial remedies regarding failure to comply; to provide for related matters; to 8 repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

An Act to provide for a homestead exemption from City of Dalton independent school district ad valorem taxes for educational purposes in the amount of \$150,000.00 of the assessed value of the homestead for residents of that school district who are 70 years of age or over, approved May 17, 2004 (Ga. L. 2004, p. 3763), as amended, is amended by revising subsection (b) of Section 1 as follows: 16 "(b) Each resident of the City of Dalton independent school district who is 70 years of age 17 or older is granted an exemption on that person's homestead from City of Dalton 18 independent school district ad valorem taxes for educational purposes in the amount 19 of \$325,000.00 of the assessed value of that homestead. The value of that property in 20 excess of such exempted amount shall remain subject to taxation."

SECTION 2.

In accordance with the requirements of Article VII, Section II of the Constitution of the State
of Georgia, this Act shall not become law unless it receives the requisite two-thirds' majority
vote in both the Senate and the House of Representatives.

SECTION 3.

26 The election superintendent of the City of Dalton shall call and conduct an election as 27 provided in this section for the purpose of submitting this Act to the electors of the City of 28 Dalton independent school district for approval or rejection. The election superintendent 29 shall conduct that election on the Tuesday following the first Monday in November, 2025, 30 and shall issue the call and conduct such election as provided by general law. The election 31 superintendent shall cause the date and purpose of the election to be published once a week 32 for two weeks immediately preceding the date thereof in the official organ of Whitfield 33 County. The ballot shall have written or printed thereon the words:

- 34 "() YES Shall the Act be approved which increases the homestead exemption from
 35 City of Dalton independent school district ad valorem taxes for educational
- 36 () NO purposes for residents of that school district who are 70 years of age or older
 37 to \$325,000.00 of the assessed value of the homestead?"

All persons desiring to vote for approval of the Act shall vote "Yes," and all persons desiring
to vote for rejection of the Act shall vote "No." If more than one-half of the votes cast on
such question are for approval of the Act, Section 1 of this Act shall become of full force and

41 effect on January 1, 2026. If the Act is not so approved or if the election is not conducted 42 as provided in this section, Section 1 of this Act shall not become effective, and this Act shall 43 be automatically repealed on the 365th calendar day following the election date provided for 44 in this section. The expense of such election shall be borne by the City of Dalton. It shall be the election superintendent's duty to certify the result thereof to the Secretary of State. 45 The provisions of this section shall be mandatory upon the election superintendent and are 46 not intended as directory. If the election superintendent fails or refuses to comply with this 47 section, any elector of the City of Dalton independent school district may apply for a writ of 48 49 mandamus to compel the election superintendent to perform his or her duties under this 50 section. If the court finds that the election superintendent has not complied with this section, 51 the court shall fashion appropriate relief requiring the election superintendent to call and conduct such election on the date required by this section or on the next date authorized for 52 53 special elections provided for in Code Section 21-2-540 of the O.C.G.A.

SECTION 4.

55 Except as otherwise provided in Section 3 of this Act, this Act shall become effective upon 56 its approval by the Governor or upon its becoming law without such approval.

57

SECTION 5.

58 All laws and parts of laws in conflict with this Act are repealed.
