## A BILL TO BE ENTITLED AN ACT

- 1 To repeal an Act creating and establishing a joint airport authority for the City of Winder and
- 2 the County of Barrow, approved March 25, 1958 (Ga. L. 1958, p. 3087), as amended,
- 3 particularly by an Act approved March 28, 1986 (Ga. L. 1986, p. 5518), and an Act approved
- 4 March 16, 1989 (Ga. L. 1989, p. 3764); to provide for a legislative purpose; to provide for
- 5 the assets and liabilities thereof; to provide for related matters; to provide for an effective
- 6 date; to repeal conflicting laws; and for other purposes.

## 7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 An Act creating and establishing a joint airport authority for the City of Winder and the
- 10 County of Barrow, approved March 25, 1958 (Ga. L. 1958, p. 3087), as amended,
- particularly by an Act approved March 28, 1986 (Ga. L. 1986, p. 5518), and an Act approved
- 12 March 16, 1989 (Ga. L. 1989, p. 3764), is hereby repealed in its entirety.

13 SECTION 2.

- 14 The purpose of this Act is to transfer all assets, obligations, and responsibilities of the
- 15 Barrow County Airport Authority to Barrow County, Georgia, to enhance efficiency,
- streamline governance, and ensure the continued operation and management of the airport.

SECTION 3.

- 18 All assets, including but not limited to real property, personal property, funds, accounts,
- 19 credits, contractual rights, leases, agreements, permits, licenses, and any other assets of any
- 20 kind, of the Barrow County Airport Authority shall be transferred to Barrow County on the
- 21 effective date of this Act. Barrow County shall assume all obligations of the Barrow County
- 22 Airport Authority, including but not limited to all outstanding debts, liabilities, and
- 23 contractual obligations of the Barrow County Airport Authority, on the effective date of this
- 24 Act.
- SECTION 4.
- 26 All existing leases, contracts, and agreements entered into by the Barrow County Airport
- 27 Authority shall remain in full force and effect and be administered by Barrow County.
- SECTION 5.
- 29 The Barrow County Airport Authority shall be dissolved upon the completion of the transfer
- 30 of assets and obligations to Barrow County.
- SECTION 6.
- 32 All references to the Barrow County Airport Authority in any enactment, including but not
- 33 limited to references in state or local laws, ordinances, resolutions, and regulations, shall be
- 34 deemed to refer to Barrow County. Barrow County shall be the legal successor to the
- 35 Barrow County Airport Authority.

- 37 This Act shall become effective upon its approval by the Governor or upon its becoming law
- 38 without such approval.

- 40 All laws and parts of laws in conflict with this Act are repealed.
