A BILL TO BE ENTITLED AN ACT

1 To amend an Act creating a Small Claims Court in Clay County, approved March 18, 1980 2 (Ga. L. 1980, p. 3545), so as to provide that the judge of the Probate Court of Clay County 3 shall also serve as the magistrate of the Magistrate Court of Clay County on or after January 1, 2021, or upon vacancy of the office of the magistrate, whichever occurs first; to 4 5 provide for the continuation in office and expiration of term of the current magistrate; to provide for the compensation of such judge for service as magistrate; to provide for 6 nonpartisan elections to the combined position of probate judge and chief magistrate; to 7 provide for related matters; to repeal conflicting laws; and for other purposes. 8

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

11 An Act creating a Small Claims Court in Clay County, approved March 18, 1980 (Ga. L.

12 1980, p. 3545), is amended by revising Section 2 to read as follows:

"SECTION 2. 13 14 (a) Pursuant to subsection (g) of Code Section 15-10-20 of the Official Code of Georgia Annotated, the magistrate of the Magistrate Court of Clay County shall not be separately 15 elected or appointed for any term of office that begins on or after January 1, 2021, but on 16 17 and after that date the judge of the Probate Court of Clay County shall serve as the magistrate of the Magistrate Court of Clay County. There shall be no election or 18 appointment in 2020 or thereafter for the office of magistrate of the Magistrate Court of 19 20 Clay County. The term of office of the judge serving as magistrate shall be concurrent with 21 such judge's term of office as the judge of the probate court. 22 (b) Effective upon the date the judge of the probate court assumes the duties of the

(b) Effective upon the date the judge of the probate court assumes the duties of the
magistrate judge, the judge of the Probate Court of Clay County shall receive a supplement
for service as magistrate judge in an amount to be fixed by the governing authority of Clay
County in addition to any compensation received for service as judge of the probate court.

26 Such supplement shall not be less than the minimum amount provided by any general law

27 for additional service by a judge of the probate court as magistrate.

- 28 (c) The magistrate of the Magistrate Court of Clay County who is serving as such on the effective date of this Act shall continue to serve as judge for the remainder of his or her 29 current term of office. During such time period, the current magistrate shall continue to 30 31 receive the same salary he or she is receiving for performing such duties as fixed by the 32 governing authority of Clay County. However, if the office of magistrate becomes vacant 33 prior to expiration of the current term, the probate judge shall immediately begin to serve 34 as magistrate. (d) All elections for the office of probate judge of Clay County, who also serves as 35 magistrate of the Magistrate Court of Clay County, conducted after the effective date of 36
- this Act shall be nonpartisan elections as provided for in Code Section 21-2-139 of the
- 38 Official Code of Georgia Annotated. Such nonpartisan elections shall be conducted at the
- 39 general nonpartisan election immediately preceding the expiration of the term of such
- 40 office and conducted as provided in Chapter 2 of Title 21 of the Official Code of Georgia
- 41 Annotated, the 'Georgia Election Code.'"

SECTION 2.

43 All laws and parts of laws in conflict with this Act are repealed.
