ADOPTED

A RESOLUTION

1 Dedicating certain portions of the state highway system; and for other purposes.

2 **PART I**

3 WHEREAS, Senator William "Bill" S. Jackson has long been recognized by the citizens of
4 this state for the vital role that he has played in leadership and his deep personal commitment
5 to the welfare of the citizens of Georgia; and

6 WHEREAS, he diligently and conscientiously devoted innumerable hours of his time,
7 talents, and energy toward the betterment of his community and state as evidenced
8 dramatically by his decades of public service; and

9 WHEREAS, a graduate of Evans High School in Columbia County, Senator Jackson founded
10 a tile and stone distribution company, Tile Center, Inc., in 1961 in Augusta which has grown
11 to include four other locations in Georgia and South Carolina; and

12 WHEREAS, his service as past president of the Merchants Association of Columbia County
13 and Martinez-Evans Jaycees, past region president of the Georgia Jaycees, and past national
14 director of the U.S. Jaycees is further testimony to his commitment to public service; and

15 WHEREAS, he was elected to serve as chairman on the Columbia County Board of
16 Education prior to serving as director of the Georgia School Boards Association; and

17 WHEREAS, Senator Jackson was elected as a representative to the Georgia House of
18 Representatives, where he served for 16 years as a member of numerous influential
19 committees, including the House Committees on Industry and Labor, Trade and Tourism,
20 Natural Resources and the Environment, and Special Judiciary; and

21 WHEREAS, his leadership continued with his service on the State Board of Corrections and
22 upon his election to the Georgia Senate in 2007, where he represented District 24 for ten
23 years as Secretary of the Rules Committee and as a member of the Appropriations,
24 Administrative Affairs, Ethics, Public Safety, Reapportionment and Redistricting, and State
25 Institutions and Property committees and served as floor leader for Governor Nathan Deal
26 for six years; and

27 WHEREAS, he has earned distinction and numerous awards and accolades, including a 2006
28 Lifetime Achievement Award from the Columbia County Chamber of Commerce; and

29 WHEREAS, Senator Jackson's significant organizational and leadership talents, his
30 remarkable patience and diplomacy, his keen sense of vision, and his sensitivity to the needs
31 of the citizens of this state have earned him the respect and admiration of his colleagues and
32 associates; and

33 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
34 Georgian be recognized appropriately by dedicating an interchange in his honor.

36 WHEREAS, Mr. Jackie Holder has long been recognized by the citizens of this state for the
37 vital role that he has played in leadership and his deep personal commitment to the welfare
38 of the citizens of Georgia; and

39 WHEREAS, he has diligently and conscientiously devoted innumerable hours of his time,
40 talents, and energy toward the betterment of his community and state as evidenced
41 dramatically by his decades of public service; and

42 WHEREAS, Mr. Holder was elected as the sole county commissioner for Bleckley County
43 in 1976, a position he proudly maintained until 1998; and

44 WHEREAS, during his tenure as county commissioner, Bleckley County experienced great
45 economic and employment growth, with increases to the county tax base and operating
46 revenues for the county; and

47 WHEREAS, Mr. Holder's leadership was instrumental in the remodeling of the county jail,
48 renovation of the court house, construction of a health department building and other

49 government offices, establishment of a county landfill, and opening of several fire stations;
50 and

51 WHEREAS, as county commissioner, Mr. Holder promoted the paving of county roads, laid
52 the foundation for establishing an organized street naming process to aid in emergency
53 response, and worked with the Georgia Department of Transportation to plan, develop, and
54 implement the Highway 87 Bypass which has greatly helped maintain steady traffic flow in
55 middle Georgia; and

56 WHEREAS, Mr. Holder worked with Bleckley Memorial Hospital during financial
57 downturns to ensure that high quality hospital and ambulatory services remained available
58 to all citizens of Bleckley County; and

59 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
60 Georgian be recognized appropriately by dedicating a road in his honor.

61 **PART III**

62 WHEREAS, Mr. Dick Campbell has long been recognized by the citizens of this state for the
63 vital role that he played in leadership and his deep personal commitment to the welfare of the
64 people of Towns County, Georgia; and

65 WHEREAS, Mr. Campbell moved to Towns County in 1936 and shortly thereafter purchased
66 the Alexander Griss Mill, which provided flour and cornmeal; and

67 WHEREAS, years later he opened a country store next to the Crooked Creek Bridge, where
68 he sold clothing and groceries to the people of Towns County and became a fixture of the
69 local community; and

70 WHEREAS, Mr. Campbell was known for his kindness, generosity, and understanding,
71 always going out of his way to help others in need; and

72 WHEREAS, he was responsible for ensuring that many hungry children were fed when their
73 families struggled to put food on the family table; and

74 WHEREAS, Mr. Campbell arranged for local children to pick blackberries to sell at his store
75 or be purchased by other stores; and

76 WHEREAS, a man of deep and abiding faith, Mr. Campbell was a good natured man who
77 also served as constable for the community of Brasstown; and

78 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments and
79 contributions of this remarkable and distinguished Georgian be recognized appropriately by
80 dedicating a bridge in his memory.

81 **PART IV**

82 WHEREAS, Mr. Cecil J. Embry was born on January 30, 1926, in Madison County, Georgia,
83 the only son of Carlton and Lula Mae Embry; and

84 WHEREAS, Mr. Embry moved to Eatonton, Georgia, in December, 1939, where he attended
85 Phoenix School, began farming with his father on New Phoenix Road, and began dairying
86 in 1941; and

87 WHEREAS, he served as a guardian of this nation's freedom and liberty with the United
88 States Navy in the Pacific Theatre during World War II; and

89 WHEREAS, at the conclusion of the war, Mr. Embry returned to the family farm on Phoenix
90 Road, which he purchased from his father, and resumed the family's dairy business; and

91 WHEREAS, in 1947 he married his beloved wife, Florence Carnes, and they had three
92 children, Roy, Shirley, and Carol, and he remained in the dairy business until his passing in
93 1985; and

94 WHEREAS, Mr. Embry was an upstanding resident of Putnam County, Georgia; an active
95 member of his community and a kind neighbor; and a longtime member of Philadelphia
96 Church; and

97 WHEREAS, Mr. Embry served his community on the Putnam County Board of Tax
98 Assessors, the Putnam Welfare Board, the Georgia Milk Producers Board, and the Eatonton
99 Cooperative Feed Board; and

100 WHEREAS, Mr. Embry was a proud member of the local American Legion Post and served
101 as Post Commander of V.F.W. Post 6686; and

102 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
103 example of America's Greatest Generation be recognized appropriately by dedicating a
104 bridge in his memory.

PART V

106 WHEREAS, the State of Georgia lost one of its finest citizens and most dedicated law
107 enforcement officers with the tragic passing of Patrol Officer Anthony Christie on
108 May 25, 2018; and

109 WHEREAS, Patrol Officer Christie served as a guardian of this nation's freedom and liberty
110 with the United States Navy for 13 years and was recognized with the Navy Achievement
111 Medal, Navy Good Conduct Medal, Global War on Terror Expeditionary Medal, and Global
112 War on Terror Medal; and

113 WHEREAS, following his dedicated service to the United States military, Patrol Officer
114 Christie joined the Savannah Police Department in December, 2015; and

115 WHEREAS, during his years with the Savannah Police Department he earned the Teamwork
116 Award for assisting with the search and rescue of a missing child who was abandoned in a
117 wooded area by a robbery suspect; and

118 WHEREAS, Patrol Officer Christie was highly regarded by the citizens of his community
119 and state and by local government officials as a person of unquestioned integrity and
120 dedication to the sound principles of law enforcement; and

121 WHEREAS, his life was tragically cut short in the line of duty when his patrol car was struck
122 by a tractor trailer on Interstate 16 while he was assisting with traffic control at the scene of
123 an accident collision investigation; and

124 WHEREAS, Patrol Officer Christie exhibited extraordinary devotion to duty, outstanding
125 loyalty, fine leadership, and meticulous attention to detail in all his duties; and

126 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
127 Georgian be recognized appropriately by dedicating an interchange in his memory.

PART VI

129 WHEREAS, Mr. Lawrence James Gillis has long been recognized by the citizens of this state
130 for the vital role that he played in leadership and his deep personal commitment to the
131 welfare of the people of Atkinson County, Georgia; and

132 WHEREAS, the Gillis family members were pioneers in the area of Atkinson County near
133 the Satilla River as some of the first settlers on both the Stokesville side of the river and the
134 Mt. Zion side of the river; and

135 WHEREAS, Mr. Gillis served as a guardian of this nation's freedom and liberty with the
136 United States Army, valiantly serving during World War I from 1917 to 1919; and

137 WHEREAS, a man of deep and abiding faith, Mr. Gillis was a founding member of Mt. Zion
138 Baptist Church's Sunday school, and he served the church for many years as a deacon; and

139 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments and
140 contributions of this remarkable and distinguished Georgian be recognized appropriately by
141 dedicating a bridge in his memory.

PART VII

143 WHEREAS, the State of Georgia lost one of its finest citizens and most dedicated law
144 enforcement officers with the tragic passing of Deputy Edward Monroe Evans on
145 November 4, 1994; and

146 WHEREAS, Deputy Evans served as dedicated and respected law enforcement officer in
147 Jackson County and was highly regarded by the citizens of his community and state and by
148 local government officials as a person of unquestioned integrity and dedication to the sound
149 principles of law enforcement; and

150 WHEREAS, his life was cut short in the line of duty when he was struck by a vehicle on
151 Interstate 85 while writing a traffic citation; and

152 WHEREAS, a true public servant, Deputy Evans was an active member of the Commerce
153 community and was known for his bright smile and for always being ready to lend a helping
154 hand to someone in need; and

155 WHEREAS, Deputy Evans exhibited extraordinary devotion to duty, outstanding loyalty,
156 fine leadership, and meticulous attention to detail in all his duties, and it is abundantly fitting
157 and proper that this remarkable and distinguished Georgian be recognized appropriately by
158 dedicating a road in his memory.

160 WHEREAS, Representative Joe Heckstall has long been recognized by the citizens of this
161 state for the vital role that he has played in leadership and his deep personal commitment to
162 the welfare of the citizens of Georgia; and

163 WHEREAS, he diligently and conscientiously devoted innumerable hours of his time,
164 talents, and energy toward the betterment of his community and state as evidenced
165 dramatically by his decades of public service; and

166 WHEREAS, Representative Heckstall was elected as a councilmember for the City of East
167 Point, making him the first African American to be elected to the city council; and

168 WHEREAS, his leadership continued upon his election to the Georgia House of
169 Representatives, where his significant organizational and leadership talents, his remarkable
170 patience and diplomacy, his keen sense of vision, and his sensitivity to the needs of the
171 citizens of this state earned him the respect and admiration of his colleagues and associates;
172 and

173 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
174 Georgian be recognized appropriately by dedicating a bridge in his honor.

175

PART IX

176 WHEREAS, Mr. Edward "Ed" Menifee has long been recognized by the citizens of this state
177 for the vital role that he has played in leadership and his deep personal commitment to the
178 welfare of the citizens of Georgia; and

179 WHEREAS, Mr. Menifee devoted innumerable hours of his time, talents, and energy toward
180 the betterment of his community and state, dedicating his life to uplifting others in need; and

181 WHEREAS, Mr. Meniffee utilized his experience and expertise as a youth educator and
182 business developer to teach entrepreneurship to young people with the Southwest Atlanta
183 Youth Business Organization (SWAYBO) and to adults through his participation in the
184 Georgia Bar Association Support to Improve Correctional Services (BASICS) program; and

185 WHEREAS, as founder and director of SWAYBO, Mr. Meniffee trained and motivated youth
186 in the areas of life, education, and business, offering weekly training sessions for 40 years;
187 and

188 WHEREAS, as program director of BASICS, Mr. Meniffee was responsible for developing
189 courses, providing instruction, and serving as a mentor to inmates and providing aid in their
190 transition to successful and productive lives upon release from prison; and

191 WHEREAS, his leadership and dedication to others were recognized with numerous awards
192 and accolades from the State Bar of Georgia; Atlanta City Council; Atlanta Business League;
193 Concerned Black Clergy; the Martin Luther King, Jr. Center for Nonviolent Social Change;
194 Southern Bell; the Equitable Company; and Delta Sigma Theta Sorority; and

195 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
196 gentleman be recognized appropriately by dedicating a bridge in his memory.

197

PART X

198 WHEREAS, Hall County has served as home to the Atlanta Falcons' training facility and
199 corporate offices since 1998; and

200 WHEREAS, for over two decades, the Falcons have served as a vital part of the fabric of the
201 Flowery Branch and Hall County communities; and

202 WHEREAS, the Falcons have helped put the Hall County region on the international map;
203 and

204 WHEREAS, the Atlanta Falcons and their players have a well-deserved reputation for giving
205 back to others through their efforts and partnerships with Habitat for Humanity, Sisu Child
206 Development Center, and numerous other organizations; and

207 WHEREAS, it is abundantly fitting and proper that the dedication and determination of these
208 fine athletes be recognized appropriately by dedicating an interchange in their honor.

PART XI

210 WHEREAS, our nation's security continues to rely on patriotic men and women who put
211 their personal lives on hold in order to place themselves in harm's way to protect the
212 freedoms that all United States citizens cherish; and

213 WHEREAS, Sergeant Corey E. Spates demonstrated a deep personal commitment to
214 protecting democracy and a willingness to sacrifice his own personal safety and comfort to
215 ensure the well-being of his fellow man; and

216 WHEREAS, he served as a guardian of this nation's freedom and liberty with the United
217 States Army and defended this country with honor and distinction, giving the ultimate
218 sacrifice on February 10, 2008, during Operation Iraqi Freedom; and

219 WHEREAS, Sergeant Spates demonstrated selfless service to this nation, and his unyielding
220 commitment to protecting the people and ideals of the United States is an inspiration to
221 others; and

222 WHEREAS, Sergeant Spates embodied the spirit of service, willing to find meaning in
223 something greater than himself, and it is abundantly fitting and proper that this remarkable
224 and distinguished Georgian be recognized appropriately by dedicating an intersection in his
225 memory.

227 WHEREAS, Mr. Jimmy Lassetter was born on March 1, 1967, in Newnan, Georgia, the
228 beloved son of George Buren Lassetter and Jacqueline Dyer Lassetter; and

229 WHEREAS, at age 12, Mr. Lassetter began working in his family's businesses, Lassetter
230 Transport, Coweta Gas Company, Troup County Gas Company, and Meriweather County
231 Gas Company; and

232 WHEREAS, Mr. Lassetter took over the family's businesses in 1979 and continued to lead
233 them successfully for over 35 years; and

234 WHEREAS, a compassionate business man, Mr. Lassetter would often provide aid or free
235 gas services to the elderly who were unable to pay for their monthly heating bills; and

236 WHEREAS, Mr. Lassetter was known by many as a father figure and leader, raising not only
237 his three biological children but many children in need as a foster parent; and

238 WHEREAS, a man of deep and abiding faith, Mr. Lassetter was a member and deacon at
239 Unity Baptist Church, where he worked tirelessly on the church's worship center and
240 adjoining facilities; and

241 WHEREAS, Mr. Lassetter's life was tragically cut short, when on December 5, 2012, he
242 entered a burning building to help a person trapped on a forklift and later passed away from
243 the severe burns he received as a result; and

244 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
245 Georgian be recognized appropriately by dedicating a road in his memory.

PART XIII

247 WHEREAS, the State of Georgia continues to mourn the loss of Ms. Marcy Tarrer Massey
248 on May 14, 2011; and

249 WHEREAS, Ms. Massey grew up in the small town of Ideal, Georgia, where she was
250 beloved by her family and many friends and enjoyed spending her free time at the local
251 swimming pool; and

252 WHEREAS, as a child, her infectious smile that brightened a room earned her the nickname
253 "Sunshine" from many of her teachers; and

254 WHEREAS, a graduate of Hallie Turner Private School in Columbus, Ms. Massey attended
255 Macon State University and Middle Georgia College; and

256 WHEREAS, a woman of deep and abiding faith, Ms. Massey attended Ideal Baptist Church,
257 and she was very involved in giving back to her community through local charity events; and

258 WHEREAS, she was a devoted mother to her two adoring daughters, making many sacrifices
259 for her children and showering them with love and support; and

260 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
261 Georgian be recognized appropriately by dedicating a road in her memory.

262 **PART XIV**

263 WHEREAS, Ms. Sparkle K. Adams has long been recognized by the citizens of this state for
264 the vital role that she has played in leadership and her deep personal commitment to the
265 welfare of the citizens of Georgia; and

266 WHEREAS, Ms. Adams served as a guardian of this nation's freedom and liberty with the
267 United States Air Force and Air Force Reserve for 25 years; and

268 WHEREAS, she has diligently and conscientiously devoted innumerable hours of her time,
269 talents, and energy toward the betterment of her community and state as evidenced
270 dramatically by her public service and military career; and

271 WHEREAS, Ms. Adams was elected as the first African American councilmember for the
272 City of Forest Park, Georgia, and served as mayor pro tem and later interim mayor; and

273 WHEREAS, as mayor pro tem, Ms. Adams consistently demonstrated her commitment to
274 sound fiscal responsibility, as shown by her ability help adjust the city's overall budget and
275 achieve a 10 percent reduction in departmental expenses during her first six months in office;
276 and

277 WHEREAS, her commitment to Forest Park and Clayton County continues today as founder
278 and executive director of Walking In Authority Teen Council, Inc. (WIATC), an organization
279 that educates teens and parents on civic duty, leadership, empowerment, accountability, and
280 responsibility through community service, networking, and relationship building; and

281 WHEREAS, Ms. Adams' leadership and guidance have been instrumental to numerous
282 organizations, including as president of the Kiwanis Club and the Atlanta Metro Chapter of
283 the National Association of Black Military Women and as a member of the Clayton County
284 Superintendent of School's Community Advisory Board and the Clayton County Board of
285 Health's Community Advisory Board; and

286 WHEREAS, she has been recognized with numerous honors and accolades, including a
287 Servant Leadership Award from the Georgia Women's Legislative Caucus; and

288 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
289 Georgian be recognized appropriately by dedicating a bridge in her honor.

PART XV

291 WHEREAS, Henry "Hank" Louis Aaron, also known as "Hammer" or "Hammerin' Hank,"
292 was born on February 5, 1934, in Mobile, Alabama, as one of seven children in a modest
293 family; and

294 WHEREAS, he went on to play 21 seasons for the Milwaukee/Atlanta Braves in the National
295 League of Major League Baseball and two seasons for the Milwaukee Brewers in the
296 American League; and

297 WHEREAS, since his retirement, Hank Aaron has worked for the Atlanta Braves and, in
298 1982, was inducted into the National Baseball Hall of Fame; and

299 WHEREAS, in 1999, Major League Baseball created the Hank Aaron Award to recognize
300 top offensive players in the league; in 2002, Hank Aaron received the Presidential Medal of
301 Freedom; and

302 WHEREAS, with his wife and fellow civic leader, Billye Suber, Hank Aaron created the
303 Hank Aaron Chasing the Dream Foundation, which has sent more than 1,000 students to
304 college at institutions such as Morehouse College, Atlanta Technical College, Berry College,
305 Clark Atlanta University, and Spelman College; and

306 WHEREAS, Morehouse School of Medicine has been a grateful recipient of the Aarons'
307 generosity, including a \$3 million gift in 2015 to expand the Hugh M. Gloster Medical
308 Education Building and create the Billye Suber Aaron Student Pavilion; and

309 WHEREAS, this iconic Atlantan has long served as a bridge to success, therefore it is
310 abundantly fitting and proper that this remarkable and distinguished Georgian be recognized
311 appropriately by dedicating a bridge in his honor which will stand as a lasting tribute to the
312 man, his legend, his legacy, and his unflagging dedication to the City of Atlanta and the
313 Westside.

PART XVI

315 WHEREAS, our nation's security continues to rely on patriotic men and women who put
316 their personal lives on hold in order to place themselves in harm's way to protect the
317 freedoms that all United States citizens cherish; and

318 WHEREAS, the 3rd United States Infantry Regiment (The Old Guard) is the oldest active
319 infantry regiment in the United States Army, with its history being traced back to the
320 Colonial days; and

321 WHEREAS, members of The Old Guard demonstrate a deep personal commitment to
322 protecting democracy and a willingness to sacrifice their own personal safety and comfort
323 to ensure the well-being of their fellow man; and

324 WHEREAS, these brave patriots serve as guardians of this nation's freedom and liberty, and
325 it is important that they are thanked for their selfless service to this nation and honored for
326 their unyielding commitment to protecting the people and ideals of the United States; and

327 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments and
328 sacrifices of these remarkable and distinguished Americans be recognized appropriately by
329 dedicating an intersection in their honor.

PART XVII

331 NOW, THEREFORE, BE IT RESOLVED AND ENACTED BY THE GENERAL
332 ASSEMBLY OF GEORGIA that the interchange at Interstate 20 and Highway 221/Exit 183
333 in Columbia County is dedicated as the Senator Bill Jackson Interchange.

334 BE IT FURTHER RESOLVED AND ENACTED that the portion of the Highway 87 Bypass
335 from the intersection of Highway 87 and Bellflower Drive to the intersection of Highway 87
336 and Holly Ross Road in Bleckley County is dedicated as the Jackie Holder Bypass.

337 BE IT FURTHER RESOLVED AND ENACTED that the bridge on State Route 66 over
338 Crooked Creek/Brasstown Creek in Towns County is dedicated as the Dick Campbell
339 Bridge.

340 BE IT FURTHER RESOLVED AND ENACTED that the bridge on State Route 16 between
341 Pea Ridge Road and Old Phoenix Road in Putnam County is dedicated as the Cecil J. Embry
342 Memorial Bridge.

343 BE IT FURTHER RESOLVED AND ENACTED that the interchange at Interstate 16 and
344 State Route 307 in Chatham County is dedicated as the SPD Patrol Officer Anthony Christie
345 Memorial Interchange.

346 BE IT FURTHER RESOLVED AND ENACTED that the bridge on State Route 64 over
347 Satilla River in Atkinson County is dedicated as the Lawrence James Gillis Bridge.

348 BE IT FURTHER RESOLVED AND ENACTED that the portion of Interstate 85 between
349 mile markers 131 and 133 in Jackson County is dedicated as the Edward Monroe Evans
350 Highway.

351 BE IT FURTHER RESOLVED AND ENACTED that the bridge at the interchange of I-285
352 and Camp Creek Parkway in Fulton County is dedicated as the Representative Joe Heckstall
353 Bridge.

354 BE IT FURTHER RESOLVED AND ENACTED that the bridge on Martin Luther King, Jr.,
355 Drive SW over Interstate 285 in Fulton County is dedicated as the Edward "Ed" Meniffee
356 Memorial Bridge.

357 BE IT FURTHER RESOLVED AND ENACTED that the new interchange on Interstate 985
358 at Exit 14 in Hall County is dedicated as the Atlanta Falcons Training Facility Interchange.

359 BE IT FURTHER RESOLVED AND ENACTED that the intersection of State Route 14 and
360 Pegasus Parkway in Troup County is dedicated as the Sgt. Corey E. Spates Purple Heart
361 Memorial Intersection.

362 BE IT FURTHER RESOLVED AND ENACTED that the portion of State Route 16 from
363 Old Carrollton Road to the Chattahoochee River is dedicated as the Jimmy Lassetter
364 Memorial Highway.

365 BE IT FURTHER RESOLVED AND ENACTED that the portion of State Route 49 South
366 from mile marker 1 to mile marker 2 in Sumter County is dedicated as the Marcy Tarrer
367 Massey Memorial Mile.

368 BE IT FURTHER RESOLVED AND ENACTED that the bridge on Interstate 75 at State
369 Route 331/Forest Parkway Exit in Clayton County is dedicated as the Sparkle K. Adams

371 BE IT FURTHER RESOLVED AND ENACTED that the bridge on Lee Street over
372 Interstate 20 in Fulton County is dedicated as the Hank Aaron Bridge.

373 BE IT FURTHER RESOLVED AND ENACTED that the intersection of GA 113 and
374 Interstate 20 at Exit 19 in Carroll County is dedicated as the 3rd U.S. Army Infantry
375 Regiment (The Old Guard) Intersection.

376 BE IT FURTHER RESOLVED that the Department of Transportation is authorized and
377 directed to erect and maintain appropriate signs dedicating the road facilities named in this
378 resolution.

379 BE IT FURTHER RESOLVED that the Secretary of the Senate is authorized and directed
380 to make appropriate copies of this resolution available for distribution to the Department of
381 Transportation; to Senator William "Bill" S. Jackson, Mr. Jackie Holder, Representative Joe
382 Heckstall, the Atlanta Falcons, Ms. Sparkle K. Adams, Mr. Henry "Hank" Louis Aaron, and
