A BILL TO BE ENTITLED  
AN ACT

1 To amend Title 42 of the Official Code of Georgia Annotated, relating to penal institutions,  
2 so as to provide that former certified employees of the Department of Corrections may retain  
3 their department issued weapon under certain circumstances; to provide that former certified  
4 employees of the State Board of Pardons and Paroles may retain their board issued weapon  
5 under certain circumstances; to provide for related matters; to repeal conflicting laws; and  
6 for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 Title 42 of the Official Code of Georgia Annotated, relating to penal insitutions, is amended  
10 by adding a new Code section to read as follows:

11 "42-2-16.

12 (a) An employee leaving the service of the department under honorable conditions who  
13 has accumulated 20 or more years of service with the department as a certified officer shall  
14 be entitled as part of such employee's compensation to retain his or her department issued  
15 weapon.

16 (b) The board is authorized to promulgate rules and regulations for the implementation of  
17 this Code section."

18 **SECTION 2.**

19 Said title is further amended by revising Code Section 42-9-9, relating to board employees  
20 and the retention of badges, as follows:

21 "42-9-9.

22 (a) The board may appoint such clerical, stenographic, supervisory, and expert assistants  
23 and may establish such qualifications for its employees as it deems necessary. In its  
24 discretion, the board may discharge such employees.

25 (b) A certified parole officer leaving the service of the board under honorable conditions  
26 who has accumulated 20 or more years of service with the board as a certified parole  
27 officer shall be entitled as part of such employee's compensation to retain his or her board  
28 issued badge. A certified parole officer employed with the board who is killed in the line  
29 of duty shall be entitled to have his or her board issued badge given to a surviving family  
30 member. Where a certified parole officer leaves the service of the board due to a disability  
31 that arose in the line of duty and such disability prevents the parole officer from further  
32 serving as a peace officer, then such disabled parole officer shall be entitled to retain his  
33 or her board issued badge regardless of the officer's number of years of service with the  
34 board. ~~The board is authorized to promulgate rules and regulations for the implementation  
35 of this subsection.~~

36 (c) An employee leaving the service of the board under honorable conditions who has  
37 accumulated 20 or more years of service with the board as a certified officer shall be  
38 entitled as part of such employee's compensation to retain his or her board issued weapon.

39 (d) The board is authorized to promulgate rules and regulations for the implementation of  
40 this Code section."

42 All laws and parts of laws in conflict with this Act are repealed.
