**AS PASSED**

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act entitled "An Act to reincorporate and provide a new charter for the City of  
2 Acworth," approved February 17, 1989 (Ga. L. 1989, p. 3512), as amended, particularly by  
3 an Act approved March 28, 1990 (Ga. L. 1990, p. 4736), an Act approved April 17, 1992  
4 (Ga. L. 1992, p. 6445), an Act approved March 30, 1993 (Ga. L. 1993, p. 4245), and an Act  
5 approved September 21, 1995 (Ga. L. 1995, Ex. Sess., p. 322), so as to adopt by reference  
6 a certain map; to repeal conflicting laws; and for other purposes.

7 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

8 **SECTION 1.**

9 An Act entitled "An Act to reincorporate and provide a new charter for the City of Acworth,"  
10 approved February 17, 1989 (Ga. L. 1989, p. 3512), as amended, particularly by an Act  
11 approved March 20, 1990 (Ga. L. 1990, p. 4736), an Act approved April 17, 1992 (Ga. L.  
12 1992, p. 6445), an Act approved March 30, 1993 (Ga. L. 1993, p. 4245), and an Act  
13 approved September 21, 1995 (Ga. L. 1995, Ex. Sess., p. 322), is amended by revising  
14 subsection (a) of Section 1.11 as follows:

15 "(a) The boundaries of this city shall be those existing on the effective date of this charter  
16 with such alterations as may be made from time to time by local law or in a manner  
17 provided by general state law. The boundaries of this city at all times shall be shown on  
18 a map, a written description, or any combination thereof, to be retained permanently in the  
19 office of the city clerk of the city and to be designated, as the case may be: "Official Map  
20 or Description of the Corporate Limits of the City of Acworth, Georgia." Photographic,  
21 typed, or other copies of such maps or description certified by the city clerk shall be  
22 admitted as evidence in all courts and shall have the same force and effect as the original  
23 map or description. The 'Official Map of the Corporate Limits of the City of Acworth,  
24 Georgia,' dated February 9, 2015, prepared by the city clerk of the City of Acworth is  
25 adopted as the official map of the corporate limits of the City of Acworth, Georgia, and the  
26 corporate boundaries of the city as of January 1, 2016, shall be reflected on said official

27 map, subject to amendment as set forth in this charter or by local Act of the General  
28 Assembly."

29 **SECTION 2.**

30 All laws and parts of laws in conflict with this Act are repealed.
