## A BILL TO BE ENTITLED AN ACT

- 1 To amend Article 2 of Chapter 7 of Title 48 of the Official Code of Georgia Annotated,
- 2 relating to the imposition, rate, computation, and exemptions from state income taxes, so as
- 3 to extend the sunset date of the existing exemption for donation of real property for
- 4 conservation use; to provide for related matters; to repeal conflicting laws; and for other
- 5 purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.

8 Article 2 of Chapter 7 of Title 48 of the Official Code of Georgia Annotated, relating to the

9 imposition, rate, computation, and exemptions from state income taxes, is amended by

10 revising subsection (d) of Code Section 48-7-29.12, relating to the income tax credit for

qualified donation of real property, as follows:

12 "(d)(1) In no event shall the total amount of any tax credit under this Code section for a

taxable year exceed the taxpayer's income tax liability. In no event shall the total amount

of the tax credit allowed to a taxpayer under subsection (b) of this Code section exceed

\$250,000.00 with respect to tax liability determined under Code Section 48-7-20 or

\$500,000.00 with respect to tax liability determined under Code Section 48-7-21. Any

unused tax credit shall be allowed to be carried forward to apply to the taxpayer's

succeeding ten years' tax liability. However, the amount in excess of such annual dollar

limits shall not be eligible for carryover to the taxpayer's succeeding years' tax liability

nor shall such excess amount be claimed by or reallocated to any other taxpayer. No such

tax credit shall be allowed the taxpayer against prior years' tax liability.

22 (2) Only one qualified donation may be made with respect to any real property that was,

in the five years prior to donation, within the same tax parcel of record, except that a

subsequent donation may be made by a person who is not a related person with respect

to any prior eligible donors of any portion of such tax parcel.

26	(3)(A) Beginning on January 1, 2016, the aggregate amount of tax credits allowed
27	under this Code section shall not exceed \$30 million per calendar year. The
28	Department of Natural Resources shall accept no new applications for the tax credits
29	allowed under this Code section after December 31, <del>2016</del> <u>2021</u> .
30	(B) Prior to any renewal of the exemption for donations of real property beyond the
31	date authorized by subparagraph (A) of this paragraph, the Department of Natural
32	Resources shall provide a report to the Governor, the President of the Senate, the
33	Speaker of the House of Representatives, and the chairpersons of the House Committee
34	on Ways and Means and the Senate Finance Committee on the activity of the program

40	(iii) The aggregate amount of income tax credits granted pursuant to this Code
41	section; and
42	(iv) A listing of the direct and indirect benefits to the state due to the donation of land
43	for conservation purposes."
